Cooperative Bulk Handling Limited (CBH) exclusive dealing notification N93439 - interested party consultation

I am writing to you as a party that may be interested in providing a submission to the Australian Competition and Consumer Commission (ACCC) in relation to the above notification received from Cooperative Bulk Handling Limited (CBH) on 11 June 2008.

In substance, CBH proposes to:

Supply storage and handling services on condition that growers or marketers acquire:

supply chain coordination services from CBH and

to the extent that grain remains in CBH's custody, that they only acquire transport services from CBH (though its nominated carrier).

CBH's proposal is hereafter referred to as 'Grain Express'

The ACCC is currently conducting a public consultation process regarding this notification. As a potentially interested party, you are invited to comment on the issues outlined in this letter.

The ACCC is aware that CBH has previously consulted the industry about its Grain Express proposal prior to lodging the notification with the ACCC. As a result of this process, the ACCC has received a number of letters directly from industry participants about their preliminary views on Grain Express. If you have written to the ACCC and would like your letter to be treated as a public submission, please confirm this in writing. Further information about requesting the ACCC to exclude information from the public register is provided at page 3 of this letter.

The notification process

The ACCC is the independent Australian government agency responsible for administering the *Trade Practices Act 1974* (the Act). A key objective of the Act is to prevent anticompetitive arrangements or conduct, thereby encouraging competition and efficiency in business resulting in a greater choice for consumers in price, quality and service.

Exclusive dealing involves one trader imposing restrictions on another trader's freedom to choose with whom, in what or where they deal. Exclusive dealing is generally prohibited under the Act.

However, the Act allows businesses to obtain immunity from legal action for exclusive dealing conduct in certain circumstances. One way businesses may obtain immunity is by lodging what is known as a 'notification' with the ACCC.

Having lodged a valid notification, CBH receives immediate immunity. The ACCC may act to remove the immunity afforded by exclusive dealing notifications like the one lodged by CBH if it is satisfied that:

the conduct has the purpose, or has, or is likely to have, the effect of substantially lessening competition and

the conduct has not resulted or is not likely to result in a benefit to the public or the benefit to the public would not outweigh the detriment to the public constituted by any lessening of competition resulting from the conduct.

The CBH notification

CBH's exclusive dealing notification and executive summary in support of the notification is attached.

A full copy of the notification will be available from the ACCC website www.accc.gov.au by following these links: 'Public registers'; 'Authorisations and notifications registers'; and 'Exclusive dealing notifications register'. Please contact the ACCC if you experience any difficulties obtaining a copy of CBH's supporting submission from the website.

CBH believes there are a number of relevant markets for assessing the impact of the proposed conduct. At their broadest, these include the markets in Western Australia for the:

supply of country grain receival, storage and handling services

- supply of bulk grain road haulage servicessupply of bulk grain rail haulage services and
- acquisition and supply of grain.

In support of its notification, CBH submits that Grain Express will result in efficiency improvements along the grain supply chain, including:

more efficient grain delivery and handling at receival points

better coordination of storage and handling

improved efficiency of the transport task

enhanced port efficiency

dynamic efficiency gains, which improve the prospect of efficient infrastructure investment in the future

better marketing decisions for growers and marketers.

CBH suggests that Grain Express will have minimal impact on competitive activity in any relevant market. In summary, CBH submits that:

marketers are not prevented from 'outturning' their grain from CBH's custody, albeit from only a number of larger 'Destination Points'

Grain Express will not deter new entrants from building competitive storage or port loading facilities

the central control of the freight task will maximise competition between road and rail and may also facilitate competitive entry in rail.

CBH also submits that any concerns regarding the potential for it to discriminate against competitors of Grain Pool Pty Ltd (CBH's grain marketing business) are alleviated by the proposed ring fencing arrangements.

Request for submissions

To assist the ACCC in its consideration of this matter it would be helpful to obtain your comments on CBH's claims. Please note, the ACCC recommends that you refer to CBH's notification and supporting submission before making a submission.

The ACCC asks for submissions to be in writing so they can be made publicly available on its public register and website.

Persons lodging a submission with the ACCC may request that information included in a submission be excluded from the public register. If a request to exclude information from the public register is made, please provide the ACCC with reasons justifying the claim for the information to be excluded. The ACCC will not grant a request to exclude information from the public register for documents which are clearly not of a confidential nature unless there are compelling reasons to do so. Guidelines for requesting information to be excluded from the public register are attached for your information.

If the ACCC decides to exclude any information from the public register, the ACCC may take it into account even though it is not publicly available.
