## Australian Dental Association Inc application for authorisation A91094 & A91095 - interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received an application for authorisation from the Australian Dental Association Inc. The Australian Dental Association is seeking authorisation for possible price fixing conduct and exclusionary provisions with respect to shared practices in the dental profession.

Submissions, including oral submissions, will be placed on the ACCC's public register subject to any request for exclusion (guidelines are attached).
