Port Waratah Coal Services Limited, Newcastle Coal Infrastructure Group Pty Ltd and Newcastle Port Corporation – applications for authorisation A91147 – A91149 & A91168 and A91169 – execution of Capacity Framework Documents

We refer to the interim authorisations granted by the ACCC on 22 July 2009 and 29 July 2009 to Port Waratah Coal Services Limited ("PWCS"), Newcastle Coal Infrastructure Group Pty Ltd ("NCIG") and Newcastle Port Corporation ("NPC") (together, the "Applicants"). The interim authorisations were granted subject to a condition that 'the Applicants execute their respective Capacity Framework Documents by 31 August 2009.'

NCIG, along with the other Applicants, has devoted a great deal of time and extensive resources to progressing the NCIG Capacity Framework Documents and, to the extent relevant, the PWCS Capacity Framework Documents.

The NCIG Capacity Framework Documents are in a very advanced form but negotiations concerning a very small number of outstanding significant matters have continued throughout the past months. The most recent negotiations took place yesterday.

Despite the desire of all NCIG shareholders to finalise all Capacity Framework Documents by 31 August 2009, it is now clear that execution of those documents by NCIG will not be possible today.

It is expected that execution of the final versions of the documents will be possible very shortly and we will inform the Commission as soon as we can be certain about the timing.
