## Third line forcing notifications N93727, N93728, N93729 & N93779 lodged by Cartridge World Pty Ltd – interested party consultation

I am writing to you as a party that may be interested in providing a submission to the Australian Competition and Consumer Commission (ACCC) in relation to third line forcing notifications lodged by Cartridge World Pty Ltd, Austcart Pty Ltd, Pacific Oasis Pty Ltd and Ink Mark Pty Ltd.

A summary of the notification process is <u>attached</u> to this letter.

## The notifications

Under the notifications lodged with the ACCC, Cartridge World Pty Ltd, Austcart Pty Ltd, Pacific Oasis Pty Ltd and Ink Mark Pty Ltd will allow a person to become a franchisee of the Cartridge World Network, and to remain a franchisee of that network, on the condition that the franchisees acquire stock and equipment only from a selection of nominated suppliers.

## Opportunity to make a submission

As a potentially interested party, you are invited to make a written submission to the ACCC regarding the likely public benefit and detriment associated with the conduct the subject of the notifications.

The ACCC asks for submissions to be in writing so they can be made publicly available. They are placed on a public register for this purpose. The ACCC may, where it is deemed appropriate, supplement written submissions with discussions with relevant parties on a mutually convenient basis.

Persons lodging a submission with the ACCC may request that information included in the submission be treated as confidential and not placed on any public register. If a request for confidentiality is made in relation to a notification the applicant is expected to provide the ACCC with reasons justifying its claim for confidentiality. The ACCC will not grant confidentiality to documents which are clearly not of a confidential nature unless there are compelling reasons to do so. Guidelines for seeking confidentiality are attached for your information.
