Workout World is the franchisor of a network of franchised and company owned stores which specialise in the retail sale of fitness equipment and associated services and products.

This notification relates to the following goods and services:

- (i) Media and advertising services used to promote franchisees' workout world businesses;
- Workout World branded products required to be used in franchisees' businesses to implement the Workout World brand image, such as Workout World branded stationery (eg, business cards, letterhead, envelopes, quotation forms) and staff uniforms;
- (iii) Shop-fitting services;

- (iv) Signage and sign writing services;
- (v) Computer hardware and software and Point of Sale (POS) systems.
- (b) **Description of the conduct or proposed conduct:** (*Refer to direction 4*)

Workout World proposes to provide franchise services to franchisees on condition that they purchase products and services of the type described in Item 2(a) from nominated approved suppliers.

4. Public benefit claims

(a) Arguments in support of notification:

The Workout World franchise network is a growing network of stores providing active competition in the sale of fitness equipment around Australia.

Workout World believes that the competitiveness of its stores in this market is maximised by ensuring that customers perceive all stores as being part of a single professional retail group with a consistent and quality brand image, 'look and feel' and customer experience. Workout World believes this can best be achieved by requiring franchisees to acquire products and services of the type described in Item 2(a) from nominated approved suppliers. In addition, the notified conduct provides a range of benefits including the following:

- The vetting and appointment of approved suppliers by Workout World provides franchisees with an efficient source of products and services known to meet the standards and specifications required by each franchisee's franchise agreement;
- The nomination of approved suppliers provides reduced costs and increased efficiency for franchisees by enabling centralised negotiation of volume discounts for a range of goods and services; and
- Requiring franchisees to acquire advertising and media services from nominated suppliers enables coordinated marketing and advertising programs to be developed across the whole of the Workout World franchise group. This, in turn, provides more efficient and effective promotion of all Workout World stores than if the marketing spends of those stores were fragmented across separate advertising and media service providers in an uncoordinated way.

The goods described in 2(a) are all supplied in separate products markets for each of the relevant goods and services.

Workout World does not believe the notified conduct is likely to give rise to any public detriment.

Workout World and its franchisees do not account for a competitively significant proportion of purchases in any affected markets. As such, the notified conduct is unlikely to have any anti-competitive effect.

To the extent that there is any effect on prices in affected markets, that effect is likely to be to reduce prices by enabling volume discounts to be negotiated.
