## Transport Workers Union of Australia SA/NT Branch - application for authorisation A91146 - interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received an application for authorisation from the Transport Workers Union of Australia SA/NT Branch (the TWU). The ACCC invites you to comment on the application. **Attached** is a summary of the authorisation process including how to make a submission to the ACCC.

The TWU is seeking authorisation to bargain on behalf of union-member and non-member 'Milk Vendors' (independent owner-drivers contracted to milk processors to deliver milk) in South Australia with milk processor National Foods Milk Limited and the future owner of the Dairy Farmers business that National Foods is selling (Parmalat has agreed to buy the business). The TWU says such collective bargaining would be over such matters as distribution-contract terms, 'rationalisation of distribution businesses' and 'any dispute' between the vendors and the processors; and that participation would be voluntary.

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed arrangements.
