It has come to my attention that the three notification lodged by Brisbane International Speedway Pty Ltd, Murray Bridge Sporting Car Club & Motorcyce Club Inc and Premier Speedway Club Warrnambool Pty Ltd are in fact declaring incorrect information.

In section 2, subsection b, point 1: it stated that the offeree has purchased a suitable licence from the National Association of Speedway Racing Pty Ltd ("NASR) in order to compete at the Track.

Attached is the current application form for a licence from the NASR website. I make reference to the top section, the Association and relevant ABN number quoted tax invoice as to the party that you are in fact joining/ paying/ this product.

In the notifications of all three venues it makes reference to NASR Pty Ltd not NASR Inc for whom you must purchase a licence from to compete at the said tracks.

Since all three are in complete contradiction I respectfully request the ACCC cancel all notifications on the grounds of inconsistency and making a misleading application.

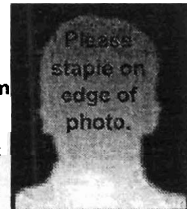
