In response to your request as an interested party to the above application.

We noted that all 3 notifications were lodged and financed by NASR Pty Ltd, we also note that:

Shareholders of NASR Pty Ltd

The National Dirt Racers Association Inc (NDRA) held an informal meeting to discuss our response to the application made by others for exclusive dealings. The following response has been completed on behalf of National Dirt Racers Association Inc and it's members.

Firstly, there seems to be a pattern forming, where as notifications are being lodged at a crucial time for the majority of the country in regards to licencing for the upcoming season. This maybe to cause unrest in the speedway community so as to force members of the community to purchase a NASR product in case it is forced by yourselves.

In all states & territories of Australia, there are non profit organisations, such as ourselves, that rely on the income from club members etc to keep their track/divisions alive and viable for all members. All income, other than operating costs, is put back into the sport in one form or another, not into shareholders or directors pockets.

We also note that the submission by ASCF Speedway Sedans Inc has not made it public that Neil Sayer, CEO is a Director of NASR Pty Ltd and that they are also shareholders of NASR Pty Ltd.

By the legal protection given to Placide Pty Ltd as trustee for the Metro Speedway Trust t/a Speedway Perth Motorplex (Perth Motorplex) and Coria Park Pty Ltd t/a Avalon International Raceway (Avalon International Raceway), in which Gavin Migro is Racing Manager of the Perth

Motorplex and also a Director of NASR Pty Ltd, Avalon International Raceway has Jeff Drew who also is a Director of NASR Pty Ltd and they also are shareholders.

In our opinion, this situation is a form of collusion with gross conflicts of interests, that many of their own members are unaware of.

By providing all of the above legal protection, it is giving NASR Pty Ltd a monopoly which is detriment to the sport as a whole.

There are many competitors/crew etc, that travel around the country for different events, we believe that by restricting entry at certain race tracks, you are limiting their desires to keep competing in this sport.
