Cuscal Limited, National Australia Bank Limited and rediATM network members applications for authorisation A91175-A91177 interested party consultation

Thank you for the opportunity to comment on the applications for authorisations sought by the abovementioned parties.

Customers Limited is an independent ATM deployer and ATM service provider, providing around 21% of ATMs currently operating in Australia, as such we have a keen interest in developments within the ATM industry.

In the applications before the Commission, the applicants have attempted to highlight the public benefits which would accrue from the proposed conduct, however their assessment appears to be limited directly to the benefits that their own members and customers will receive, rather than a wider public benefits test.

Importantly, the proposed conduct could influence the decisions of an estimated 20% of all debit card holders, based on the combined cardholder base of the applicants, as to how and where they access cash via the ATM network. The future behaviour of this group of debit card holders is likely to produce ramifications for the wider ATM network and may well have implications for all cardholders.

We are concerned that the authorisation of the applications may potentially set a precedent for other large financial institutions to follow which may have an unintended impact on the operation of the ATM system and reverse some of the progress made through the introduction of the ATM reform package in March 2009, including the Reserve Bank's Access Regime for the ATM System. However, this appears to be more within the bailiwick of the Reserve Bank and the Payments Systems Board rather than the Commission.
