Notification of Exclusive Dealing: Good Price Pharmacy Group

We act for Good Price Pharmacy Franchising Pty Ltd ("GPPF") and Good Price Pharmacy Management Pty Ltd ("GPPM").

On 15 October 2008, we lodged on behalf of GPPM a Notification of Exclusive Dealing N93623 in relation to stock purchasing arrangements for franchised "Good Price Pharmacy Warehouse" stores. Legal immunity was granted by the ACCC on and from 29 October 2008. A copy of the letter from the ACCC dated 24 October 2008 notifying GPPM of this fact is attached.

Following an internal restructure of the Good Price Pharmacy Group:

- GPPF has been established as the new franchising entity within the Good Price Pharmacy Group; and
- GPPM will provide management services to non-franchised stores.

Franchised stores (managed by GPPF) and non-franchised stores (managed by GPPM) are required to purchase products from authorised suppliers.

Accordingly, we attach the following for your consideration:

- Form G (Notification of Exclusive Dealing) by GPPF;
- 2. Form G (Notification of Exclusive Dealing) by GPPM; and
- 3. cheques totalling \$200, being the lodgement fees for the notification by each of GPPF and GPPM.

Exclusive dealing notification N93623 lodged by Good Price Pharmacy Management Pty Ltd

I refer to the above third line forcing notification lodged with the Australian Competition and Consumer Commission (the ACCC) on 15 October 2008. The notification has been placed on the ACCC's public register.

Good Price Pharmacy Management Pty Ltd (GPPM) proposes to offer franchise agreements to potential franchisees of Good Price Pharmacy Warehouses outlets on condition that the franchisee agrees to:

- purchase various pharmaceutical, health and beauty products from authorised suppliers and
- maintain such products in such quantities as GPPM may reasonable require from time to time.

A franchisee wishing to make purchases from a supplier other an authorised supplier must obtain approval from GPPM.

Legal immunity conferred by the notification came into force on 29 October 2008.

On the basis of the information that you have provided, it is not intended that further action be taken in this matter at this stage.

This assessment has been made on the basis that GPPM, in promoting the franchise arrangement, will ensure that potential franchisees are appropriately informed of the terms and conditions governing the franchise arrangement. The ACCC takes this opportunity to remind GPPM of its obligations to prospective franchisees under the Franchising Code of Conduct, in particular its duty of disclosure of all relevant conditions of the franchise agreement.

As with any notification, please note that the ACCC may act to remove the immunity afforded by the notification at a later stage if it is satisfied that the likely benefit to the public from the conduct will not outweigh the likely detriment to the public from the conduct.

A copy of this letter has been placed on the ACCC's public register.

- purchase various pharmaceutical, health and beauty products from authorised suppliers; and

GPPF will negotiate deals with authorised suppliers for the supply of pharmaceutical, health and beauty products to each GPP Warehouse franchisee. The authorised suppliers will in each case be selected based on the following:

(i) the products supplied are appropriate for sale in a GPP Warehouse;

- their ability to ensure efficient supply of the relevant products to all franchisees; and
- (iii) their ability to supply products at competitive rates.

Clause 8.2 of the franchise agreement entered or to be entered into with franchisees requires the franchisees to purchase goods and services from these authorised suppliers. The clause provides that:

- (i) The Franchisor shall provide to the Franchisee a list of Authorised Suppliers, which may be updated or amended by the Franchisor from time to time. These suppliers have been chosen by the Franchisor because they provide to franchisees benefits such as the ability to service a large chain of shops, display and promotional support, efficient billing, rebates and discounts, product obsolescence protection and product liability warranties.
- (ii) A Franchisee wishing to make purchases from a supplier other than an Authorised Supplier must obtain approval from the Franchisor.
- (iii) If the Franchisor is satisfied in its absolute discretion, after investigation, that the new supplier will not detract from the Store Image, quality and pricing policies associated with the Store System and can offer significant benefits, that supplier may be listed by the Franchisor as an Authorised Supplier.
