North West Shelf Project joint venture partners' applications for authorisation A91220 - A91223 - draft determination

The Australian Competition and Consumer Commission (the ACCC) has issued a draft determination in respect of the above applications for authorisation.

Draft determination

For the reasons set out in its draft determination, the ACCC proposes to grant conditional authorisation to the North West Shelf Project (NWS Project) partners to jointly market and sell their natural gas entitlements in WA until 31 December 2015.

The ACCC also proposes to grant authorisation to the NWS Project partners to give effect to existing contracts for their full term and to give effect to contracts entered into during the period of authorisation for a duration of no longer than five years.

The ACCC proposes to impose conditions on authorisation requiring the NWS Project partners to implement and have annually audited a set of ring fencing arrangements.

A copy of the ACCC's draft determination is attached. The ACCC's assessment of the proposed arrangements is set out in Chapter 4.

Next steps

Once the ACCC issues a draft determination, the Applicants or any interested party may request that the ACCC convene a 'pre-decision conference'. A pre-decision conference provides the opportunity for interested parties to make oral submissions in relation to the draft determination. Conferences are conducted informally and while legal or professional advisers are able to attend they are not entitled to participate in the discussion.

If you wish the ACCC to hold a pre-decision conference in relation to the draft determination, you must notify the ACCC in writing by 23 July 2010.

You are also invited to make a written submission in response to the ACCC's draft determination. Submissions should be lodged by 30 July 2010.

The ACCC will consider any submissions it receives, including any oral submissions made should a pre-decision conference be called, and will then release a final determination in relation to these applications.

In addition to commenting on the ACCC's preliminary assessment of the proposed arrangements, the ACCC seeks the views of interested parties on the appropriate period of authorisation for the parties to give effect to existing contracts.

Submissions will be placed on the ACCC's public register subject to any request for exclusion (guidelines are attached).

Timetable

The ACCC will continue to progress its assessment of the application in a timely manner. An updated indicative timetable is set out below for your information.

31 March 2010	Lodgement of the applications and supporting submission.
6 April 2010	Public consultation process begins.
8 July 2010	Draft determination.
July/August 2010	Public consultation on draft determination including any conference if called.
August/September 2010	Final determination.
