Notification of third line forcing - Bupa Australia & Ancillary Providers

Bupa Australia Pty Ltd 81 000 057 590 ("Bupa") has implemented criteria for formally recognising providers of ancillary services ("Ancillary Providers") to ensure that health benefits are only paid in respect of Ancillary Providers who are qualified and competent to practise. As part of this recognition criteria, Bupa Australia required its providers of Ancillary Providers to be members of specified professional associations.

It is arguable that these recognition requirements may be considered a contravention of section 47 of the *Trade Practices Act 1974 (Cth)*. As a result, we enclose:

- (1) a Form G notification on behalf of Bupa; and
- (2) a submission supporting the Form G notification highlighting the public benefit associated with the proposal and the absence of any misuse of market power.

As discussed with Sharon Clancy the ACCC has lodgement fees of \$200 from recent notifications that were confirmed invalid. Please use \$100 for the lodgement of new notification.

Bupa Australia has provider recognition criteria to ensure that health benefits are only paid in respect of health providers who are qualified and competent to practise. As part of this provider recognition criteria, Bupa Australia requires its providers of ancillary services ("Ancillary Providers") to be members of specified professional associations. SUBMISSION BY BUPA AUSTRALIA PTY LTD ("BUPA AUSTRALIA") IN SUPPORT OF NOTIFICATIONS UNDER SECTION 93 OF THE TRADE PRACTICES ACT 1974

This submission supports a separate Form G notification lodged on behalf of Bupa Australia.

1. Overview of proposed conduct

- Bupa Australia is a private health insurer in accordance with the Private Health Insurance Act 2007 (Cth).
- 1.2 Bupa Australia is committed to ensuring its members receive the highest quality in health care. As a result, Bupa Australia has implemented criteria for formally recognising providers of ancillary services ("Ancillary Providers") to ensure that health benefits are only paid in respect of Ancillary Providers who are qualified and competent to practise.
- 1.3 Bupa Australia requires its Ancillary Providers to be members of specified professional associations. Bupa Australia will not recognise an Ancillary Provider unless it has the appropriate membership (ie Bupa Australia will not pay benefits in respect of an "unrecognised" Ancillary Provider).
- 1.4 It is arguable that these arrangements may involve Bupa Australia engaging in a contravention of sections 47(6) and (7) of the Trade Practices Act 1974 (Cth). This will be the case if Bupa Australia is considered to be:
 - (a) giving or allowing or offering to give or allow, a discount, allowance, rebate or credit in relation to the supply of goods or services to Ancillary Providers on the condition that those Ancillary Providers acquire membership of specified professional associations; or
 - (b) refusing to give or allow a discount, allowance, rebate or credit in relation to the supply of goods or services to Ancillary Providers for the reason that those Ancillary Providers have not acquired or have not agreed to acquire membership of specified professional associations.

2. The recognition criteria

- 2.1 For an Ancillary Provider who is a Naturopath, Homeopath, Acupuncturist, Remedial Massage Therapists or Herbalist Bupa Australia has some discretion in formulating its recognition criteria. In the interests of consistency and fairness both to consumers and Ancillary Providers, Bupa Australia has formulated its recognition criteria on the principle that health fund benefits should only be paid in respect of providers who are qualified and competent to practise. This strives to ensure that Bupa Australia members will receive the necessary high quality of service from Ancillary Providers.
- 2.2 For an Ancillary Provider who is a Naturopath, Homeopath, Acupuncturist, Remedial Massage Therapists or Herbalist the provider must be internally recognised by Bupa Australia. Recognition can be obtained either by:

- direct application to Bupa Australia, or
- being a member of a professional industry association
- 2.3 Where an Ancillary Provider chooses to obtain recognition by being a member of a professional industry association, Bupa Australia has certain professional associations of which the Ancillary Provider must be a member as it believes that these associations have a comprehensive and respected process for accepting members. Further, in the interests of saving consumers time and money by not mandating a new process that Bupa Australia has decided to recognise Ancillary Providers that are members of those associations. A list of these associations in respect of each profession is listed in Annexure 1 of this submission.
- 2.4 We also attach for your information, a copy of the terms that Bupa Australia has developed which set out Bupa Australia's relationship with each profession or recognised Ancillary Provider (see "Our Provider Recognition Criteria" in Annexure 2 of this submission).

3. Product and services

We consider the relevant products and services for assessing these notifications are:

- · ancillary health care; and
- private health insurance.

4. Public Benefit

Bupa Australia's proposed conduct has significant benefits to the public because it:

- ensures that health fund benefits are only paid in respect of Ancillary
 Providers who are qualified and competent to practise. As a result, Bupa
 Australia members receive the necessary high level of care from all
 recognised Ancillary Providers; and
- provides Bupa Australia members with better value for money from their private health membership – due to the higher quality of service received from the many recognised Ancillary Providers.

5. Competitive effects

- 5.1 The proposed conduct will have no detrimental effects on competition.

 Competition in respect of ancillary health care and private health insurance is considerable and there is a wide variety of competitors. No Ancillary Providers possess a substantial degree of market power, nor does Bupa Australia.
- 5.2 The conduct in no way limits the choice of Ancillary Providers because:
 - Ancillary Providers may continue providing services to all customers, regardless of whether or not the Ancillary Providers obtain recognition from Bupa Australia. However customers who receive treatment from

unrecognised Ancillary Providers will not be able to claim health insurance rebates from Bupa Australia; and

• Ancillary Providers may seek recognition from the many competitors of Bupa Australia that supply private health insurance.

6. Conclusion

For the reasons set out above, we believe the Commission should not serve a notice under section 93 of the TPA in respect of the attached notifications. This is because the conduct will cause no detriment and will generate tangible public benefits.

Introduction

Bupa Australia

"BUPA" means Bupa Australia Pty Ltd ABN 81 00 057 590 trading as MBF, NRMA Health Insurance, SGIO Health Insurance, HBA and Mutual Community.

The BUPA Recognition Criteria and Registration Process for Complementary/ Alternative Therapy providers have been developed:

- To ensure that customers are directed to trained Complementary / Alternative therapy providers.
- To ensure that benefits paid for services rendered by Complementary / Alternative therapy providers are only paid where the service was provided by BUPA Recognised Providers.
- To establish the BUPA Recognition Criteria for Complementary / Alternative therapy providers with reference to industry and government requirements.
- To minimise and manage operational expenditure by establishing an automated registration process via a professional association which meets the requirements of rule 10 of the Private Health Insurance (Accreditation) Rules 2008 and whose members meet the BUPA Recognition Criteria.

Recognition Criteria

BUPA Recognised Provider status will be granted to applicants who:

- Meet the recognition criteria for the modality in which they seek recognition
- Meet the Compulsory Additional Recognition Requirements
- Are members of a professional organisation which meets the requirements of rule 10 of the Private Health Insurance (Accreditation) Rules 2008
- Are members of an Association that has an agreement with BUPA Australia.
- · Agree to abide by Our Ancillary Provider Terms.

Please note: This is a working document and can be amended to account for legislative and industry changes, including the addition of new courses and the establishment of arrangements with professional associations for electronic registration of their members. Courses included in this document are subject to change due to discontinuation and/or name change. Courses listed are not a comprehensive list and are only courses that we are aware of that meet the current BUPA requirements.

Educational qualifications

The qualifications mentioned in the criteria should be considered as minimum qualifications.

Diploma and Advanced Diploma qualifications must be obtained from an Australian Registered Training Organisation (RTO)

Degree qualifications must be obtained from an Australian University or Australian Registered Training Organisation (RTO) however overseas degree qualifications will be recognised if equivalency can be established.

Overseas degree qualifications must be independently validated and assessed by Vetassess to establish equivalency. (Providers can apply online www.qualverify.com or by phone on (03) 9655 4845.)

Any educational qualifications substantially attained by distance /online / external learning will not be recognised. Distance components to be confined to health science and generic subjects.

Registration Process

Registration is available only by membership of a professional organisation which meets the requirements of rule 10 of the Private Health Insurance (Accreditation) Rules 2008 and which has agreed to supply BUPA with electronic address details of its members who meet the BUPA Recognition Criteria and who have agreed to abide by Our Ancillary Provider Terms.

Any professional association requesting to establish association registration for their members will need to make a submission to BUPA detailing their entry conditions and requirements, including their compliance with rule 10 of the Private Health Insurance (Accreditation) Rules 2008.

It is important to note that:

- BUPA has established arrangements with accredited associations for them to provide us with electronic lists (email or on disc) of their members who have met the BUPA Recognition Criteria and who have agreed to abide by Our Ancillary Provider Terms.
- The arrangement involves receiving regular updated lists of any membership changes including provider address details changing, new members to the association.
- BUPA will continue to extend this arrangement to other associations meeting our requirements.

Compulsory Additional Requirements

The following requirements are compulsory for all BUPA Recognised Complementary /Alternative Therapists.

1. Private Practice

BUPA Recognised Providers are required to be in private practice. The BUPA definition of private practice for the purposes of the BUPA Recognition Criteria is as follows:

"Private practice means that the person is self employed and solely responsible for their own operating cost, sick leave, annual leave etc, and that their income is primarily derived from the fee to patient/client for services rendered, at that practice.

Where a provider practices in conjunction with other providers, they can be deemed to be in private practice providing that the income of that group is derived from fees received from patients/clients of the practice. The group or individual practitioner is not funded or contracted to any public or private authority except for the payment to that authority for rent of premises"

2. Continuing Professional Education (CPE)

Demonstrate participation in Continuing Professional Education, aiming to maintain practical and theoretical skills in areas directly related to the chosen field of practice by completing a minimum of 20 CPE points per annum. (1 point = 1 hour)

3. Professional Indemnity Insurance

Possession of current Professional Indemnity Insurance of \$1,000,000 minimum, per claim. The professional indemnity insurance policy must cover each practice and each modality covered by this application.

4. Senior First Aid certificate

Possession of a current Senior/Workplace First Aid certificate or equivalent

5. Full¹ membership

Full membership only with relevant association which meets the requirements of rule 10 of the Private Health Insurance (Accreditation) Rules 2008 is accepted. Student membership is not acceptable.

¹ The associations listed are those that have agreed to supply BUPA with electronic address details of their members who meet the BUPA Recognition Criteria and have agreed to abide by the BUPA Ancillary Provider Terms.

ACUPUNCTURE

Recognised by MBF, NRMA Health Insurance, SGIO Health Insurance, SGIC Health Insurance, HBA and Mutual Community

Providers applying on or after 1 July 2009

In order to obtain recognition as a Bupa Australia Recognised provider, for acupuncture benefit payment purposes, the applicant will:

Graduates of Australian Programmes

- Have completed as a minimum, a 4 year full-time or equivalent, Australian Bachelor Degree majoring in Acupuncture.
- The Degree program must substantially conform to Australian Guidelines for Traditional Chinese Medicine Education (2001), especially with regard to curriculum content, overall duration of the programme, mode of delivery, and extent of supervised clinical practice.
 - Any educational qualifications substantially attained by distance/on-line/external mode will not be recognised.
- Meet the compulsory additional requirements.
- Currently available Australian Masters programmes do not meet criteria for recognition.
- Applicants without an Australian University Bachelor Degree in Acupuncture must have their current competencies assessed by a process approved by Bupa Australia to determine equivalency. For further information please contact Bupa direct.
- The following courses meet these minimum requirements:
