**Exclusive dealing notifications N93185, N31439, N31440**

We act for Ticketek Pty Limited (**Ticketek**).

We refer to our letter dated 5 November 2007 in relation to Ticketek's exclusive dealing notification N93185, and the Commission's letter dated 15 November 2007. The subject matter of notification N93185 was Ticketek's agreement with Optus in relation to the 'yes' Tickets program.

Ticketek and Optus have ceased to offer Optus Customers the 'yes' Tickets program. Accordingly, Ticketek hereby withdraws notification N93185.

Ticketek continues to provide offers to individuals who are holders of a payment card (either a debit card or a credit card) bearing the VISA acceptance mark, pursuant to exclusive dealing notifications N31439 and N31440.

Our letter of 5 November 2007 set out the steps that Ticketek would take where Optus and VISA priority booking periods were both run in respect of the same event. Following the withdrawal of notification N93185, these circumstances will no longer apply.

Ticketek will continue to provide information to the Commission about the VISA arrangements described in notifications N31439 and N31440, in accordance with our letter to the Commission dated 30 September 2005.
