NOTIFICATION OF EXCLUSIVE DEALING

To the Australian Competition and Consumer Commission:

Notice is hereby given, in accordance with subsection 93 (1) of the *Trade Practices Act 1974*, of particulars of conduct or of proposed conduct of a kind referred to subsections 47 (2), (3), (4), (5), (6), (7), (8) or (9) of that Act in which the person giving notice engages or proposes to engage.

Delaware North is a hospitality company that operates in a number of venues and holiday resorts nationally.

The Services to which this notice relates are:

- a) the review and approval of supply side trading partners (suppliers, vendors, subcontractors etc); and
- b) the provision of web-based business portal services for the storage, sharing, management and communication of compliance and other information between trading partners.

(b) Description of the conduct or proposed conduct:

Delaware North proposes to require supply side trading partners to become members of International Compliance Information Exchange (iCIX) Pty Ltd and to establish their own business site with iCIX (**Conduct**). iCIX is a

web-based business portal which allows members to store, share and manage documentation, information and other related communication.

3. Persons, or classes of persons, affected or likely to be affected by the notified conduct

4. Public benefit claims

(a) Arguments in support of notification:

The main benefit in having suppliers of goods and services as members of iCIX is that it enables a more robust register of compliance documents, including but not limited to insurance, product safety, food safety and trade licences. This has the effect of:

- fostering business efficiency through the industry wide exchange of compliance information using iCIX;
- improving product quality through the use of iCIX product Withdrawal and Corrective Action modules; and
- promoting competition by allowing a buyer to check the real time compliance of a supplier or prospective supplier.

iCIX enables Delaware North to check that suppliers have current public liability, workers compensation, professional indemnity and other relevant

insurances. The expected benefits arising out of the Conduct are passed on to consumers, employees and stakeholders.

The public benefits which will flow from the Contract include the following.

- Enhanced consumer safety through facilitation and management of compliance in relation to product safety, quality assurance and other certifications achieved by real time access to the most appropriate and up to date information stored on the site.
 - Eg: As the 'controller of a premises' (under a range of state based legislation), the Conduct assists Delaware North risk management approach to protect employees, tenants and visitors to Delaware North buildings. This ultimately benefits employees, visitors, shareholders and investors across Australia.
- Reduction in transaction time and costs across the industry for both
 Delaware North and its suppliers arising from the ability to access and
 place documents for common use on the iCIX site. Once a supplier
 joins iCIX, they can elect to share their information with all their
 customers, not just Delaware North.
 - O Eg: Suppliers are commonly obliged to obtain or facilitate an assessment of the same matters for multiple parties through audit reports. By placing a report on the site, reference may be made to that report by other parties, potentially avoiding the need to obtain duplicate or additional reports.
- The promotion of efficiencies and certainty for parties to a transaction.
 Such certainty arises from the ability to exchange and execute agreements electronically, the iCIX system's ability to archive documents for future reference and retrieval and access to product specifications and other compliance requirements.
- Security of information, arising from use of an independent third party site to store and record documentation. The parties have the ability to maintain the confidentiality of material placed on the site through restricting access to nominated individuals.

The Conduct will encourage competition amongst suppliers to improve and maintain standards of compliance.

(b) Facts and evidence relied upon in support of these claims:

None in addition to the facts described above.

5. Market definition

The relevant markets in which the services described at 2(a) are supplied or acquired are:

- a) the worldwide market for the supply and acquisition of procurements services; and
- b) the worldwide market for the supply and acquisition of web-based business portal services.

In respect of the market referred to in (a) above, procurement services are supplied and acquired by a vast and diverse number of parties, including those who supply and acquire the goods and services which are the subject of the procurements as well as third party procurers. Similarly, in respect of the market referred to in (b) above, there is a vast and diverse number of providers and acquirers of web-based business portal services, including businesses which host their own business portal services.

At this time, Delaware North. considers that there are no substitutions available for the comprehensive service provided by iCIX.

6. Public detriments

(a) Detriments to the public resulting or likely to result from the notification, in particular the likely effect of the notified conduct on the prices of the goods or services described at 2 (a) above and the prices of goods or services in other affected markets:

Delaware North does not consider there to be any pubic detriments flowing from the Conduct. The public benefits described in 4(a) above outweigh any perceived public detriments. A supplier who does not wish to be a member of iCIX is free to supply goods and services to other organisations through other means including other web-based business portals. There will continue to be vigorous and effective competition in the relevant markets. The Conduct will have negligence, if any, impact in those markets.

In addition, the minimal cost of membership to iCIX (currently \$330 pa) is likely to be recouped in the transaction and compliance cost savings which

can be achieved though use of the system. Also, the numbers of supplier and distributors participating in the Conduct will be very small relative to the overall size of the markets affected by the Conduct. Accordingly, Delaware North. believes that competition in those markets will not be affected to any material extent by the Conduct.
