Third line forcing notification N95566 lodged by First Class Taxis Pty Ltd - interested party consultation

The Australian Competition and Consumer Commission (ACCC) has received a third line forcing notification from First Class Taxis Pty Ltd (First Class).

The purpose of this letter is to provide you with an opportunity to comment on this notification. Attached for your information is a summary of the notification process, including how to make a submission to the ACCC.

The notification process

Notification provides protection from legal action for conduct that might otherwise raise concerns under the competition provisions of the *Competition and Consumer Act 2010* (the Act). Broadly, the ACCC may allow a third line forcing notification to stand if it is satisfied that the likely benefit to the public arising from the conduct will outweigh the likely detriment to the public arising from the conduct.

The protection afforded by a third line forcing notification arises 14 days after the notification is lodged with the ACCC. The ACCC may revoke a third line forcing notification at any time if it determines that the conduct to which the notification relates no longer delivers a net public benefit.

Notification N95566 lodged by First Class

First Class operates a taxi management company on the Gold Coast in Queensland.

On 27 September 2011, First Class lodged notification N95566 with the ACCC. Under the notification, First Class proposes to bail its taxis to drivers on condition that the driver acquires Electronic Funds Transfer at Point of Sale (EFTPOS) services only from a supplier approved by First Class.

First Class notes that it will reasonably approve all suppliers that satisfy all of the following criteria:

- Provide a charge account system which gives passengers a line of credit to pay for taxi fares and related charges
- Provide a payment system which allows the taxi driver to process non-cash payment systems and other payment systems as mandated by law
- Provide processing services which facilitate the distribution between First Class and the taxi driver of passenger fares received by EFTPOS
- Provide EFTPOS terminals that will be hardwired to taxi cab metres so as to allow real time visibility and recording of all transactions by First Class
- Provide a payment system which does not permit payment of any monies into an account other than those designated by First Class.

Request for submissions

To assist the ACCC in its consideration of the notification, the ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, arising from the proposed conduct.

The ACCC would appreciate your comments on First Class's criteria for approved suppliers and the ability of EFTPOS providers to meet these requirements. In particular, the ACCC is interested in your views on what impact this conduct is likely to have on the range of possible EFTPOS service providers available to taxi drivers and whether it will affect driver's ability to use a secondary EFTPOS terminal.

If you intend to provide a submission in relation to First Class's third line forcing notification, please do so by 4 November 2011.
