The notification relates to:

(i) goods: being the supply of security doors, physical barrier systems and alarm systems; and

- (ii) services: being remote alarm monitoring services.
- (b) Description of the conduct or proposed conduct:

ADT proposes to supply or offer to supply electronic monitoring of alarms and related services at a particular price, or to give a discount or rebate on such supply, on the condition that the customer also acquires alarm installation and/or security doors and/or physical barrier systems from **Security365 Pty Ltd** (ABN 98 140 453 363) or its duly appointed franchisees.

Alternatively ADT proposes to refuse to supply or offer to supply electronic monitoring of alarms at a particular price, or to offer any discount or rebate, for the reason that the customer has not acquired alarm installation and/or security doors and/or physical barrier systems from **Security365 Pty Ltd** (ABN 98 140 453 363) or its duly appointed franchisees.

3. Persons, or classes of persons, affected or likely to be affected by the notified conduct

All persons wishing to acquire monitored alarms and security doors in Australia.

4. Public benefit claims

(a) Arguments in support of notification:

The conduct described in 2(b) above is a direct benefit to consumers and will be of public benefit because:

- (i) It will enable customers a 'one stop shop' for acquiring complementary home and business security products (monitored alarm and security doors);
- (ii) Customers may be eligible for a reduced package price if they acquire the bundle of goods and services via a Security365 franchisee.
- (b) Facts and evidence relied upon in support of these claims:
 - (i) Customers for home or business security products will commonly want static security measures, such as security doors, in addition to a monitored alarm. Currently such services are generally not offered as a bundle and therefore the customer must acquire each good/service separately from different suppliers and does not have any opportunity to access the benefits of acquiring these goods/services as part of a package via a single point of supply.

5. Market definition
