Notification of third line forcing – Bupa Australia & Roses Only, Hampers Only and Fruit Only

Bupa Australia Pty Ltd ABN 81 000 057 590 trading as Bupa, MBF, HBA and Mutual Community ("Bupa Australia") has negotiated an arrangement with Roses Only & Lush Flowers Pty Ltd ABN 60 065 255 692 trading as Roses Only, Hampers Only and Fruit Only ("Roses Only & Lush Flowers").

Under this arrangement, Roses Only & Lush Flowers offers a discount on purchases of its product range including Roses Only, Hampers Only and Fruit Only to customers who have taken out health insurance with Bupa, MBF, HBA or Mutual Community.

It is arguable that this may involve a contravention of section 47 of the Competition and Consumer Act 2010 (Cth). As a result, we enclose for your consideration:

- (1) a Form G notification on behalf of Roses Only & Lush Flowers;
- (2) a submission made by Bupa Australia on behalf of Roses Only & Lush Flowers supporting the Form G notification highlighting the public benefit associated with the proposal and the absence of any misuse of market power;
- (3) a cheque for \$100 as payment for lodging fees; and
- a written consent from Roses Only & Lush Flowers consenting to Bupa Australia lodging the Form G notification on Roses Only & Lush Flowers' behalf.

We would appreciate it if you would copy us in on any response you provide to Roses Only & Lush Flowers.

SUBMISSION BY BUPA AUSTRALIA IN SUPPORT OF NOTIFICATION UNDER SECTION 93 OF THE COMPETITION AND CONSUMER ACT 2010

This submission is made by Bupa Australia Pty Ltd ABN 81 000 057 590 and trading as Bupa, MBF, HBA and Mutual Community ("Bupa Australia") on behalf of Roses Only & Lush Flowers and supports the Form G notification attached.

1. Overview of proposed conduct

- 1.1 Bupa Australia is a private health insurer under the *Private Heath Insurance Act 2007 (Cth)*.
- 1.2 Roses Only & Lush Flowers, trading as Roses Only, Hampers Only and Fruit Only are providers of online flowers, fruit and hampers.
- 1.3 Bupa Australia has negotiated an arrangement with Roses Only & Lush Flowers. Under this arrangement, Roses Only & Lush Flowers offers a discount on its entire product range, to Bupa Australia members (that is, those who have health insurance with Bupa, MBF, HBA or Mutual Community).
- 1.4 This conduct by Roses Only & Lush Flowers is arguably a contravention of sections 47(6) and (7) of the *Competition and Consumer Act 2010 (Cth)* if Roses only & Lush Flowers is considered to be:
 - (a) giving or allowing or offering to give or allow, a discount, allowance, rebate or credit in relation to the supply of good or services to consumers on the condition that those consumers take out private health insurance with Bupa, MBF, HBA or Mutual Community; or
 - (b) refusing to give or allow a discount, allowance, rebate or credit in relation to the supply of goods or services to consumers for the reason that those consumers have not acquired or have not agreed to acquire private health insurance from Bupa, MBF, HBA or Mutual Community.

2. Details of offer

The table below sets out the details of the offer.

Business/Product	Description of offer
10% discount on	Available to all Bupa, MBF, HBA and Mutual Community
online purchases	customers.
	Bupa, MBF, HBA and Mutual Community customers receive a 10% discount on online purchases at Roses Only, Hampers Only and Fruit Only when they purchase products online at Bupa Australia's website located at bupa.com.au.

3. Products and services

We consider the relevant products and services to which this notification relates are:

· leisure services; and

• private health insurance.

4. Public Benefit

The proposed conduct of Roses Only & Lush Flowers offers significant benefits to the public because:

- the discount make the products more affordable and better value for consumers; and
- the conduct motivates competitors to offer similar benefits and discounts and therefore increases competition in the products.

5. Competitive effects

- 5.1 The proposed conduct will have no detrimental effects on competition. Competition is strong and there are other companies competing for business on an equal footing.
- 5.2 The offer in no way limits the choice of consumers because:
 - Roses Only & Lush Flowers will continue to offer its products to consumers at the regular prices, regardless of whether or not the consumers are Bupa Australia members; and
 - consumers are free to purchase from other competing suppliers.

6. Conclusion

For the reasons set out above, we believe the Commission should not serve a notice under section 93 of the CCA in respect of the attached notifications. This is because the conduct will cause no detriment and will generate tangible public benefits.

Roses Only & Lush Flowers proposes to offer members of Bupa Australia Pty Ltd ABN 81 000 057 590 trading as Bupa, MBF, HBA and Mutual Community discounts on its regular prices from time to time. Please refer to the attached submission for further details.

Consumers who are members of Bupa, MBF, HBA or Mutual Community.

(b) Number of those persons

The offer will be available to all Bupa, MBF, HBA and Mutual Community customers. At the present time Bupa, MBF, HBA and Mutual Community together cover around 3,250,592 lives on 1,548,417 memberships.

(c) Where number of persons state in item 3(b)(i) is less than 50, their names and addresses

Not applicable as the number of persons stated in item 3(b)(i) is greater than 50.

4. Public benefit claims

5.
