St Vincent's Health Australia & Ors Applications for Authorisation (A91295, A91296, A91297)

We refer to your letter dated 24 May 2012.

All capitalised terms and acronyms in this letter are defined in our clients' submission in support of its applications for authorisation.

### Exclusive dealing conduct

In its applications for authorisation lodged on 23 March 2012, the applicants sought authorisation under s 88 of the CCA to operate all entities within the SVHA Group as if they were a single economic entity or effectively merged. In respect of exclusive dealing, the proposed conduct in respect of which authorisation was sought included the tying or bundling of goods or services in such a way that the supply of goods or services at one entity (such as SVPHS) may be conditional on a third person's acquiring goods or services from another entity in the SVHA Group, where the third party is a patient, a doctor or a Funding Organisation.

The applicants' primary aim in making this application was to have authorised proposed exclusive dealing conduct where the third party is a Funding Organisation. Since making the application, it has become apparent to the applicants that some parties have concerns about the potential for restriction of choice for SVPHS patients and medical practitioners with respect to pathology, imaging and other ancillary services.

It was never the intention of the applicants to restrict choice of service provider for patients or medical practitioners at SVPHS for imaging, pathology or other ancillary services. Although

the SVHA Group would not have used the authorisation, if granted, in this manner; in light of the concerns raised, the applicants clarify that their applications for authorisation in respect of exclusive dealing conduct relate to the tying or bundling of goods or services in such a way that the supply of goods or services at one entity (such as SVPHS) may be conditional on a third person's acquiring goods or services from another entity in the SVHA Group, where the third party is a Funding Organisation.

We trust that this amendment alleviates the need for the applicants to provide responses to questions 1 to 5 and question 7 in your letter.

### **SVHA** Group negotiations

Following the move to a single governance structure from 1 October 2010, SVHA has been moving to a national, more centralised approach in health funding negotiations for its wholly owned subsidiaries and related bodies corporate. As part of this approach, funding parameters are endorsed by a single fiduciary board, all deals are approved by the SVHA chief executive officer, negotiations are co-ordinated by a group health fund team and there is a one group negotiation representative for each funder.

A key component of the centralisation is the alignment of contract dates with each funder for SVHA's wholly owned subsidiaries and related bodies corporate. Whilst the SVHA Group entities contracted with each funder remain unchanged, SVHA is implementing a two-stage process to transition to group negotiations:

- Stage 1: alignment of corporate contract renewal dates with each funder for SVHA's wholly owned subsidiaries and related bodies corporate; and
- Stage 2: commencement of national group negotiations from 1 November 2012.

The proposed conduct in the applications for authorisation seeks to bring SVPHS into the centralised approach to health funding negotiations adopted by the remainder of the SVHA Group.

### [RESTRICTION OF PUBLICATION OF PART CLAIMED]

In relation to medical supplies procurement, SVHA is also moving to centralised negotiations. Attached is a flyer circulated to vendors in the past week about SVHA's Group procurement services (**Annexure**) which demonstrates that SVHA is proactively seeking to engage with vendors about changes in SVHA's governance, the formation of a new Group Procurement Office, SVHA's adoption of the National E-Health Transition Authority National Product Catalogue and GS1 International Standards.

Finally, in the applicants' submission, the concerns raised by Medibank Private Limited about collective boycotts are misconceived. We reiterate that all members of the SVHA Group with the exception of SVPHS can lawfully act as a single economic entity, including engaging in collective negotiations with Funding Organisations and joint purchasing activity. The proposed conduct would simply involve all members of the SVHA Group (including SVPHS) being able to lawfully act as a single economic entity in circumstances where SVPHS, in substance, functions as part of the same economic entity already.
