

Attached is a completed Form B and supporting attachments. In relation to the QNF membership list and Constitution (Attachments A and C) I will email these as they are best in electronic form.

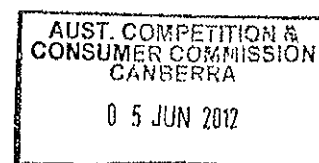
I also attach a letter of fee waiver from the ACCC, dated 1 June 2012.

Fee waiver request for the Queensland Newsagents Federation

I refer to your letter of 31 May 2012 to the Australian Competition and Consumer Commission (ACCC) in respect of a proposed application for authorisation. In your letter you have requested that the ACCC grant a fee waiver in respect of the proposed arrangements.

In particular, you have requested that the fee to be paid in relation to an application from the Queensland Newsagents Federation (QNF) for collective bargaining with Golden Casket Lotteries in Queensland (which is part of the Tattersall's Group) be waived in whole.

In support of your request, among other things, you submitted that:

- QNF is an association of very small businesses
- QNF does not make a profit and has no commercial operations and
- QNF and its members would find it difficult to pay the application fee.

Having regard to the above, as a person authorised to assess fee waiver requests for and on behalf of the ACCC, I wish to advise that the application fee to be paid by QNF has been waived in whole.

This decision will remain in force for a period of three months. The three month period will expire on 1 September 2012.

A copy of this letter should accompany the application for authorisation to be lodged by QNF. The cover letter to the application should mention that a letter from the ACCC regarding a fee waiver is enclosed with the application. The application together with this letter will be placed on the public register at that time.

If the application for authorisation is lodged by QNF after 1 September 2012, a full application fee of \$7500 will apply, unless a subsequent request for a fee waiver is made and ultimately approved by the ACCC.



SUBMISSION IN RELATION TO APPLICATION FOR AUTHORISATION BY QNF FOR COLLECTIVE BARGAINING BY NEWSAGENTS WITH GOLDEN CASKET

The Principle.

“A single negotiation process through collective bargaining may offer a more efficient and informed bargaining process, relative to a situation where multiple negotiation processes are necessary”

ACCC -AMA Collective Bargaining decision, December 2008.

The Application

The Application seeks ACCC authorisation for Queensland Newsagents Association (QNF) to collectively bargain with Golden Casket (GC) in relation to the distribution services that QNF members provide to Golden Casket.

The ACCC has previously authorised and re authorised QNF to collectively bargain with newspaper publishers and magazine distributors. (A90804)

Further the ACCC has authorised and re authorised Queensland lottery agents (LAQ) to collectively bargain with Golden Casket. (A9110)

This Application draws upon the above mentioned authorisation decisions plus ACCC authorisation and notification decisions respectively in NSW and SA in relation to collective bargaining with local counterparts of Golden Casket.

The Applicant also seeks **an interim authorisation** pending a final determination.

Purpose of the Application

QNF members are all newsagents and most, if not all, are agents for GC. Many are members of the Golden Casket Agents association (LAQ) but by no means all.

There are 504 QNF members who are part of this Application. QNF, now that former ANF members have joined QNF, is the only newsagent specific association in Queensland.

QNF is linked to ANF, NANA and VANA thereby covering newsagents throughout all of Australia. However they all act individually when dealing with local lottery operators, even though the same operator has the licence in some States.

The situation arises that the LAQ is authorised to collectively bargain on behalf of its members but QNF cannot do so legally. This causes a competitive disadvantage between newsagents who provide the same services to GC but will have differing negotiation facilities. This competitive disadvantage has been exploited.

The purpose of newsagents association seeking protection for collective negotiation is to give the newsagents more input and cost effectiveness into the competitive process between buyers and suppliers so that the outcome in terms of commission rates, supply terms and conditions will, more closely, approximate the outcome one could expect under competitive conditions (equally matched buyers and suppliers).

Under the non collective bargaining arrangements the targets of any collective bargaining sought to be protected present individual newsagents with standard form contracts that are weighted in favour of the target.

QNF wishes to conduct negotiations on behalf of its members, particularly those who are not LAQ members, in relation to the terms and conditions of agency agreements and arrangements with GC, including,

- Commission fees
- Handling fees
- Agency application fees
- Support services levies
- Freight charges
- Product ordering fees
- Equipment hire costs
- Retail image design and agency subsidy and insurances, and
- Changes to the agent's manual.

QNF also wishes to conduct negotiations on behalf of members in relation to the impact on current GC agents when new agencies are being proposed by GC.

The agency agreements are standard across the industry and must be approved by the Queensland Office of Gaming Regulation. (QOGR)

At the moment QNF is not able to collectively negotiate in relation to such agreements and feel at a competitive disadvantage. In fact GC has refused to involve QNF in negotiations due to the fact that QNF does not have ACCC 'approval' to negotiate collectively on behalf of its members with lottery operators in Queensland.

The above list is not exclusive and other issues may arise from time to time that are currently unforeseen.

The Queensland Lottery Industry,

Lotteries in Queensland are regulated by the Queensland Office of Liquor, Gaming and Racing (OLGR).

The Australian Gambling Statistics (AGS) publication, produced by the Queensland Office of Economic and Statistical Research in co-operation with all Australian state and territory governments, provides an overview of gambling in Australia. The most recent edition of the AGS, released in February 2011, provides data for the entire range of legalised gaming products, including lotteries, in Queensland and Australia, from 1980/81 to 2008/09

We provide the following summary of the findings of the most recent AGS publication.

Turnover from lotto and instant lotteries (scratchies) in 2008/09 was in the order of \$1 billion in Queensland accounted for around Turnover on lotto was around \$776 million and turnover on instant lotto around \$234 million.

Per capita (18 years and over) turnover for lotto and instant lotteries was around \$300 in Queensland.

Lotto and instant lotto account for around 2.5% of national gambling turnover and around 3.4% of gambling turnover in Queensland. Gambling through gaming machines accounts for around 80% of gambling turnover in New South Wales, the Australian Capital Territory and South Australia and around 64% of gambling turnover in Queensland and Victoria.

Attachment D is some relevant extract from the most recent AGS Report.

The Target-Golden Casket

Golden Casket is the only organisation currently licensed to run lotteries in Queensland holding an exclusive license to run lotteries in Queensland until 2016. Post 2016 there may be other licencees.

Golden Casket was owned by the Queensland Government from 1920 until 29 June 2007 when Golden Casket became a wholly owned subsidiary of Tattersall's Holding Pty Ltd, a subsidiary of the Tatts Group Limited.

Golden Casket offers a range of lottery products in Queensland through its network of around 1100 licensed agents and via Lotto Direct, a system that allows customers to purchase lottery products online 24 hours a day, 7 days a week.

Lotteries run by Golden Casket include:

- Saturday Gold Lotto
- Wednesday Gold Lotto
- Powerball
- Oz lotto

- Casket draws
- Super 66, and
- Instant 'scratchies.'

Lottery agents

Lottery products in Queensland are sold through a network of around 1100 licensed agents and, other than in the case of instant lotto products, online.

Of the approximately 1100 licensed lottery agents in Queensland, around 900 offer the full range of lottery products while 200 offer instant lotto products only. It is understood that these numbers have remained fairly stable over the last five years.

The geographical distribution of agents broadly mirrors population distribution. And Golden Casket's policy is to ensure that all Queensland towns with a population greater than 1000 people are serviced by at least one agency. Around 80% of agencies are run in conjunction with newsagencies.

Agents are paid commission and handling fees with commission rates varying between types of lotto games, between online lotto and purchases through agents and between lotto and instant scratchies.

QNF submits that average commission and handling fees as a percentage of total lotto and instant lotto sales have fallen over the last 10 years from 7.73% in 1997/98 to 7.41% in 2006/07.

The Applicant

QNF is the trade association in Queensland that represents specialist newsagents, it has approximately 50 members and that represents some 65% of newsagents in Qld. QNF members are all small businesses who employ up to 30 staff.

There is now only one association in Qld that represents specialist newsagents. In 2010 the QNF became the agent in Queensland for the Australian Newsagents Federation. That arrangement was the subject of an exclusive dealing notification.

QNF's key role is to represent its members in Qld and where appropriate to act on behalf of its members on a collective basis. QNF is seen as an effective representative of its members and takes a pro active role in commercial issues on behalf of its members. Not only does QNF act collectively but will also pursue matters on behalf individual members.

The market

The applicant considers that the relevant fields of competition are those for:

- the provision of lotto and instant lotto distribution services to Golden Casket, and
- the supply of lottery products to consumers.

This is in line with the LAQ authorisation.

The provision of lotto and instant lotto distribution services to Golden Casket

Golden Casket lottery agents distribute lotto and instant lotto products in return for a commission on the sale of those products. Lottery agents compete with each other, and with other prospective agents, in the provision of these services

Golden Casket is the monopoly supplier of lottery products in Queensland and as such, the monopsony acquirer of distribution services from agents.

The supply of lottery products to consumers

Lottery agents compete with each other in the retail of lottery products to consumers.

In the LAQ decisions the ACCC notes the wide range of other gambling and wagering products also available to consumers.

Detriment.

The applicant does not see any detriment in collective bargaining by QNF. Any anti competitive impact would be of a very low level if any. Casket agents who are more numerous can already act collectively but very much in their own interests.

The industry is highly regulated and contracts are standard. That being the case it is important that all distributors are at the negotiation table otherwise some anti competitive elements could arise.

The arrangements will be voluntary and hence any detriment is unlikely.

It is highly unlikely that extension of the collective bargaining facility to QNF will have any negative impact and no impact at all on consumers.

ACCC view on collective bargaining arrangements. (taken from the LAQ collective bargaining authorisation decision)

“Under collective bargaining arrangements, competitors come together to negotiate terms and conditions, which can include price, with a supplier or customer.

Generally speaking, competition between individual businesses generates price signals which direct resources to their most efficient use. Collective agreements to negotiate terms and conditions can interfere with these price signals and accordingly lead to inefficiencies. However, the extent of the detriment and the impact on competition of the collective agreement will depend upon the specific circumstances involved.

The ACCC has previously identified that the anti-competitive effect of collective bargaining arrangements constituted by lost efficiencies is likely to be more limited where:

- the level of negotiations between individual members of the group and the proposed counterparties absent the collective arrangements is low*

- *participation in the collective bargaining arrangement is voluntary*
- *there are restrictions on the coverage or composition of the group and*
- *there is no boycott activity”.*

Level of negotiations absent the collective arrangements

Where the level of individual bargaining between members of a proposed bargaining group and the counterparty is low, the difference between the level of competition with or without the collective arrangements may also be low.

There are around 500 QNF member lottery agents situated throughout Queensland.

However, the counterparty to negotiations, Golden Casket, is the monopoly supplier of lottery products in Queensland (and therefore the monopsony acquirer of lottery distribution services). Consequently, Golden Casket is in a strong bargaining position vis-à-vis newsagents who are also lottery agents,

It appears, in respect of their dealings with Golden Casket, that the newsagents agents are price takers with little influence over handling and commission fees. This is particularly the case given the importance of lottery products to most agents and that Golden Casket is the sole supplier of these products in Queensland.

Voluntary participation

Participation in the proposed collective bargaining arrangement is voluntary. Individual newsagents are free to individually contract with Golden Casket if they, and Golden Casket, wish to do so.

Golden Casket is under no obligation to participate, or continue to participate, in the collective bargaining arrangements. Absent any boycott activity, as discussed below, Golden Casket remains free to negotiate individually with newsagents either in addition to, or instead of, collective negotiations.

Coverage or composition of the group

The ACCC has stated in the past that where the size of bargaining groups is restricted, any anticompetitive effect is likely to be smaller having regard to the smaller area of trade directly affected and having regard to the competition provided by those suppliers outside the group.

QNF's collective bargaining arrangement extends to under half of all lottery agents in Queensland. It is noted that LAQ authorisation is likely to account for a similar slice of the Qld lottery agents.

However, the counterparty to negotiations, Golden Casket, has considerable bargaining power when negotiating with its agents,

Golden Casket is the monopsony acquirer of lottery distribution services in Queensland and the distribution of these services is an important source of revenue for most lottery agents. In contrast, Golden Casket has distribution options other than

individual lottery agents party to the arrangements available to it

Despite that fact that the collective bargaining groups include a significant number of Queensland lottery agents, Golden Casket's countervailing bargaining power constrains the extent to which lottery agents could negotiate, for example, on prices and other terms and conditions, limiting the potential anticompetitive effects of the collective arrangements.

The ACCC has noted Golden Casket's preference for a single standard form agency agreement and agent's manual covering all Queensland lottery agents. Consequently, terms and conditions collectively negotiated by the LAQ or QNF on behalf of its members are also likely to be applied all lottery agents in Qld. members.

Consequently it is important that as many as possible of those agents are represented at the negotiating table.

Boycott activity

This application does not extend to boycott activity.

For the reasons set out above QNF is of the view that any anti competitive detriment is likely to be minimal. In fact there will be competition for ideas and members between QNF and LAQ.

Public benefits

As with most collective bargaining some public benefits arise. They are hard to quantify but they are real.

It is the position the target has a reputation of not negotiating and the only way that negotiations might arise is if they are collective. Unless they are collective important issues might not be addressed. Nor will newsagents issues necessarily be addressed by Casket agents.

There is a clear disparity of bargaining power and the only way that that might be remedied with possibly mutually beneficial outcomes is by collective negotiation.

The other benefit is that any improvements in the standard form agreements should come out of input by all those involved and not just one category.

In the LAQ authorisation the ACCC stated,

"Competition between buyers and sellers on terms and conditions of supply, through the process of negotiation, is likely to lead to an efficient outcome. In the past the ACCC has recognised that if buyer or sellers are constrained in their ability to provide input into those terms and conditions, the most efficient outcome may not be achieved.

Where this is the case, collective bargaining may help businesses by providing a

mechanism through which they can provide greater input into contracts and be more commercially efficient.

As noted in the ACCC's consideration of the effects on competition of the collective bargaining arrangements, there currently appears to be an imbalance in bargaining positions between Golden Casket and individual lottery agents. Golden Casket, is the monopoly supplier of lottery products in Queensland (and therefore the monopsony acquirer of lottery distribution services) and it appears, at least in respect of their dealings with Golden Casket, that lottery agents are price takers with little influence over handling and commission fees. This is particularly the case given the importance of lottery products to most agents and that Golden Casket is the sole supplier of these products in Queensland.

Such an imbalance in bargaining power is likely to be reflected in the terms and conditions of supply negotiated between the parties. In particular, the use of standard form contracts and the low prospect of individual negotiations do give rise to some barriers to effective input by lottery agents into contractual terms and conditions.

Accordingly, it may be that improving lottery agents bargaining position may increase the degree to which they have input into these terms and conditions. This improved input can provide a mechanism through which the negotiating parties can identify and achieve greater efficiencies in their businesses, for example, addressing common contractual problems in a more streamlined and effective manner

While the collective bargaining arrangements may improve lottery agents bargaining position, it is not likely to change the bargaining power relativities between the parties to such an extent that any existing imbalance in bargaining power would be reversed.

As noted in the ACCC's consideration of the effects on competition of the collective bargaining arrangements, it would still be open to Golden Casket to negotiate with lottery agents on an individual basis if that is its preference. However, the arrangements for which re-authorisation is sought provide lottery agents with a greater voice in negotiations and, if both sides consider it appropriate, allow for contract terms and conditions to be negotiated that take greater account of any issues identified by lottery agents

Similarly, the collective bargaining arrangements do not limit the ability to tailor collectively negotiated contracts to individual circumstances where appropriate"

QNF submits that the above applies to its situation.

The Counter factual

The counter factual will be the status quo where the LAQ has an advantage over QNF and that leads to a competitive in equality and some QNF members who are GC agents but not members of LAQ are not represented in negotiations with GC.

QNF members who are GC agents but not members of LAQ will not have input into the negotiation process.
