(b) Short description of business carried on by that person:

RE/MAX holds the master franchise of the RE/MAX® franchise system in Australia from RE/MAX, LLC, a Delaware limited liability company incorporated in the state of Colorado, USA.

RE/MAX has granted franchises to a network of RE/MAX® real estate office franchises in Australia, which offers a variety of real estate services to the general public.

2. Notified arrangement

(a) Description of the goods or services in relation to the supply or acquisition of which this notice relates:

This notice relates to a system called RE/MAXNet software ("Software"), a real estate management software system provided by Renet Pty Ltd ("Renet") that has capabilities compatible with RE/MAX communications and data reporting requirements.

The Software includes information and data on contact management, consumer property listings, marketing tools, contact management, associate receivables, listings and lead management, sales, contract management.

(b) Description of the conduct or proposed conduct:

RE/MAX requires all its franchisees to implement and use the Software and pay subscription fees to Renet as a condition of the franchise agreement.

3. Persons, or classes of persons, affected or likely to be affected by the notified conduct

(a) Class or classes of persons to which the conduct relates:

RE/MAX franchisees.

- (b) Number of those persons:
 - (i) At present time:

Set out at Annexure A is a list of RE/MAX franchised businesses as at the date of this notice which will be affected by the notified conduct.

4. Public benefit claims

(a) Arguments in support of notification:

By requiring RE/MAX franchisees to subscribe to the Software, RE/MAX will ensure:

- (i) that all franchisees have access to a high quality real estate management and reporting system;
- that all franchisees gain full access to the benefits of the RE/MAX franchise system by utilising a system that is provided by a specialist provider and tailored to the RE/MAX franchise system;
- (iii) that the quality and efficacy of service provided by RE/MAX franchisees will be consistent throughout the franchised network. Accordingly, customers that visit any of the franchised offices are assured of consistency of service across the franchise network;
- (iv) business efficacy of all franchisees will be enhanced because franchisees do not have to source and subscribe to comparable software or services individually.

(b) Facts and evidence relied upon in support of these claims:

Although there will be costs payable by the franchisees to subscribe to the Software, RE/MAX believes that the benefits to the franchisees in improved operational efficiencies will outweigh the financial costs for subscribing to the Software.

RE/MAX undertook an analysis of comparable systems available on the market, and determined that the Software meets RE/MAX requirements and is the best solution for RE/MAX franchisees.

5. Market definition

Provide a description of the market(s) in which the goods or services described at 2 (a) are supplied or acquired and other affected markets including: significant suppliers and acquirers; substitutes available for the relevant goods or services; any restriction on the supply or acquisition of the relevant goods or services (for example geographic or legal restrictions):

- (a) Providers of comparable real estate management softwares could be affected. However, the effectiveness of the individual operation of each RE/MAX franchise, and the operation of the RE/MAX franchise network as a whole, are reliant on the proposed arrangements set out in this notification.
- (b) Without the proposed arrangements, RE/MAX franchisees would be able to acquire other softwares from service providers of their choosing, and suppliers could compete for the businesses of these individual franchisees. RE/MAX does not consider that this would significantly increase the level of competition in the relevant market, but would tend to cause disparity between systems used by, and the service level expected from, different RE/MAX franchisees, thereby potentially moving away from the established concept of the RE/MAX franchise system.
- (c) Further, there are various other independent and franchised real estate businesses in competition with the RE/MAX franchise system across Australia, and accordingly there is a large part of the market that is available to be accessed by other providers of comparable real estate management softwares.

6. Public detriments

(a) Detriments to the public resulting or likely to result from the notification, in particular the likely effect of the notified conduct on the

prices of the goods or services described at 2 (a) above and the prices of goods or services in other affected markets:

RE/MAX does not consider that there is likely to be any detriment to the public as a result of the notified conduct because:

- (i) the public is able to take advantage of improved efficiencies and improved level of service across the RE/MAX franchise network; and
- (ii) the public is able to take advantage of the benefits flowing from the consistent and uniform range of services across the RE/MAX franchise network.
