**TAB Limited and Tabcorp Wagering Manager (Vic) Pty Ltd applications for authorisation A91419 - A91424 – proposed variation to applications**

The Australian Competition and Consumer Commission (the ACCC) recently sought comment from you about applications for authorisation lodged by TAB Limited (**TAB**) and Tabcorp Wagering Manager (Vic) Pty Ltd (**Tabcorp**), collectively referred to as Tabcorp.

As you may be aware, Tabcorp is seeking to acquire the ACTTAB business from the ACT Government and this acquisition is currently being considered by the ACCC. Tabcorp is now seeking to vary its applications for authorisation so in the event that its proposed acquisition of ACTTAB is successful, it would be authorised to have a Tabcorp entity enter into international pooling arrangements in respect of the ACT totalisator as well.
