RESPONSE TO ACCC'S INFORMATION REQUEST

- 1. Does the proposed cooperation agreement extend to Alitalia's 'Air One' brand?
 - 1.1 The Alitalia Low Cost Carrier "Air One Smart Carrier" brand and legal entity is not being transferred to New Alitalia. Air One discontinued its services to the general public in October 2014. Its routes have either been transferred to Alitalia or cancelled.
- 2. Please clarify whether the current code-share arrangement provides for block sale or free sale of capacity and on which routes.
 - 2.1 The current code-share arrangement is a free-sale agreement and relates to the following routes for Winter 2014/2015:



 - 3.1 **Schedule 1** to this document contains a list of all of Alitalia's operated national routes, international short-haul routes and international long haul routes.

Please indicate the city pair routes on which the Applicants currently overlap.

- 3.2 The only city pairs on which Etihad and Alitalia (the **Applicants**) currently overlap with direct operated flights is FCO-AUH and this has only been since July 2014. The European Commission has considered this route in detail as part of its merger control review of the acquisition of joint control over New Alitalia and concluded that, for the majority of passengers, the route FCO-AUH is actually substitutable with FCO-DXB (on which Emirates had some 80% market share) and no competition concerns were raised.
- 4. Detail all existing arrangements and agreements between Alitalia and Qantas and indicate any changes anticipated in the future if the proposed partnership between the Applicants proceeds.
