APESMA is seeking authorisation to collectively negotiate the terms of engagement on behalf of existing and future members who are independent contractors and provide interpreting and translating services. APESMA is also seeking authorisation to advise translators and interpreters in relation to what constitutes fair rates of pay and other contract terms for services.
