2. Notified Arrangement

(a) Description of the goods or services in relation to the supply or acquisition of which this notice relates:

Cricket NSW proposes to provide limited free or discounted food and/or drinks ("consumables") to certain persons in attendance at various cricket matches.

(b) Description of the conduct or proposed conduct:

Cricket NSW proposes to provide limited free or discounted consumables to certain persons in attendance at certain Cricket NSW cricket matches on condition that the free or discounted consumables will only be available on presentation of an original coupon from The Daily Telegraph/ The Sunday Telegraph (the **Relevant Newspaper**).

Cricket NSW will be able to refuse to supply the free or discounted consumables on the basis that the person seeking such free or discounted consumables does not have an original coupon from the Relevant Newspaper.

The promotional offers are exclusive to the Relevant Newspaper in that Cricket NSW will not make the same offer in another publication or online media at the same time.

Persons, or Classes of Persons, Affected or Likely to be Affected by the Notified Conduct

- (a) Class or classes of persons to which the conduct relates:Current and future people purchasing consumables at any Cricket NSW match.
- (b) Number of those Persons:
 - (i) At present time:Substantially more than 50

4. Public benefit claims

There are a number of significant public benefits which result from the proposed conduct:

- (a) A number of customers will be offered free or discounted consumables when they present an original coupon from the Relevant Newspaper;
- (b) the discount may encourage competitors of the Relevant Newspapers, including other newspapers, magazines and online media, to offer customers similar promotions; and
- (c) competitors of Cricket NSW may be encouraged to offer customers discounts through the Relevant Newspapers as well as other newspapers or magazines.

5. Market definition

It is not necessary to precisely define the applicable relevant markets affected as even in the narrowest potential market, the notified conduct will not result in any lessening of competition.

6. Public detriments

The notified conduct would not result in public detriment, anti-competitive or otherwise, for the following reasons.

- Members of the public would be under no obligation to accept the offer from Cricket NSW.
- The general public would be free to acquire services from Cricket NSW without any obligation to acquire any Relevant Newspapers.

Many advertisers promote their products through coupons or promotions offered in newspapers, magazine and online media to increase awareness of new products or encourage general brand awareness and loyalty.

Many printed newspapers, magazines and online media services in Australia offer discount coupons or promotions to third parties' goods and services. This is to encourage loyalty to the publication or online service by customers and advertisers and increases competition between newspapers, media and online media services.

The notified conduct would have no appreciable effect on competition between providers of news and information services.
