Application for revocation of authorisation A91100 and substitution of new authorisation A91392 – final determination

The Australian Competition and Consumer Commission (the ACCC) has issued a final determination in respect of an application from the Australian Medical Association Limited (**AMA**) to revoke a previous authorisation and substitute it with a new authorisation (reauthorisation).

A copy of the ACCC's determination is attached, including a summary of its reasons. For the reasons set out in its determination, the ACCC revokes authorisation A91100 and grants authorisation A91392 in substitution. The substitute authorisation is for the AMA and its state and territory AMA organisations (except New South Wales and the Australian Capital Territory) to continue to collectively negotiate with relevant state and territory health departments, the terms of contracts for rural general practitioners providing services as Visiting Medical Officers in public hospitals and health facilities in rural and remote areas of Australia (except for NSW and the ACT) for ten years.

Interim authorisation

On 22 January 2014, the ACCC granted interim authorisation in respect of the application with effect from 1 March 2014.

Interim authorisation will remain in place until the date the ACCC's final determination comes into effect or until the ACCC decides to revoke interim authorisation.

Application for review

Pursuant to section 101 of the *Competition and Consumer Act 2010*, a person dissatisfied with this determination may apply to the Australian Competition Tribunal for its review. An application for review must be made within 21 days of the date of this determination; that is, on or before **Wednesday**, **9 April 2014**. If no application for a review is lodged by this date, the ACCC's determination will come into force on **Thursday**, **10 April 2014**.

An application for review of the ACCC's determination should be lodged directly with the Australian Competition Tribunal. The Australian Competition Tribunal is a separate body from the ACCC and is located within the Federal Court of Australia.
