## NSW Farmers' Association application for authorisation A91417 - interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received an application for authorisation from the NSW Farmers' Association on behalf of their Contract Poultry Group members. The ACCC invites you to comment on the application. Attached is a summary of the authorisation process including how to make a submission to the ACCC.

The NSW Farmers' Association is seeking authorisation, on behalf of its members who provide chicken, turkey and duck growing services, to collectively bargain the terms and conditions of contracts (including price) with chicken, turkey and duck processors.

As background, chicken and turkey (but not duck) growers are currently able to collectively bargain with processors under the *Poultry Meat Industry Act 1986 (NSW)*. The NSW Farmers' Association has been advised that the NSW Government intends to repeal the *Poultry Meat Industry Act* in the near future.

May/June 2014	Draft determination.
May/June 2014	Public consultation on draft determination including any conference if called.
July 2014	Final determination.
