Lottery Agents Association of Victoria Inc application for revocation of authorisation A91126 and substitution of new authorisation A91425 – interested party consultation

The Australian Competition and Consumer Commission (the ACCC) is currently conducting a consultation process on an application for re-authorisation (application for revocation and substitution) received from Lottery Agents Association of Victoria Inc (LAAV) on 8 May 2014.

The purpose of this letter is to invite you, as a potentially interested party, to comment on the application. Please see the ACCC's publication <u>Authorisation process - the basics</u> for a summary of the authorisation process and how to make a submission to the ACCC.

Application for 're-authorisation'

LAAV is seeking the revocation of authorisation of A91126 and substitution of authorisation A91425 for ten years to allow it to continue collective bargaining on behalf of its members over the terms and conditions of retailer agreements and arrangements with Tatts Group and Intralot and any other lottery operator licenced by the Victorian Government (the **Conduct**).

Background

The ACCC previously granted authorisation to allow LAAV to negotiate the terms and conditions of retailer agreements and arrangements with Tattersall's Sweeps Pty Ltd (Tattersall's) and Intralot Australia Pty Ltd until 25 June 2014.

Interim authorisation

LAAV has also requested interim authorisation to engage in the Conduct.

The ACCC endeavours to deal with requests for interim authorisation quickly. In making an assessment as to whether it is appropriate to grant interim authorisation, the ACCC is not required to undertake a full assessment of the benefit and detriment likely to arise as a result of the proposed conduct.

The ACCC decides whether to grant interim authorisation on a case by case basis. Should an applicant request interim authorisation, the ACCC will usually consider a range of factors, including:

- harm to the applicant and other parties if interim is or is not granted
- possible benefit and detriment to the public
- · the urgency of the matter and
- whether the market would be able to return to substantially its preinterim state if the ACCC should later deny authorisation.

Request for submissions

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed arrangements. Further, the ACCC invites you to outline your general experience of the Conduct during the term of the previous authorisation. The ACCC would also welcome your views on the public benefits and detriments you consider have actually resulted from the Conduct during the previous authorisation period.

If you intend to provide a submission in relation to LAAV's request for interim authorisation and substantive application for re-authorisation please do so by **28 May 2014**. Submissions should be emailed to adjudication@accc.gov.au with the subject "A91425 – Lottery Agents Association of Victoria – submission".

Alternatively, if you would like to provide comments orally, please contact Tanya Hobbs on 02 6243 1029 or via email adjudication@accc.gov.au to organise a suitable time.

Submissions, including oral submissions, will be placed on the ACCC's public register subject to any request for exclusion. Please see the ACCC's publication <u>Guidelines for excluding information from the public register</u>.

The ACCC will progress its assessment of the application in a timely manner. An indicative timetable is set out below for your information.

mid Jun 2014	ACCC decision regarding interim authorisation.
June 2014	Draft determination.
June/July 2014	Public consultation on draft determination including any conference if called.
July/August 2014	Final determination.
