This notice relates to the provision of corporate airfares under corporate sales agreements.

VAH and VAIH (as relevant) propose to supply or offer to supply airfares at a particular price, or give or allow a discount in relation to the supply of airfares, from time to time on condition that the customer has entered into a corporate sales agreement with an Alliance partner of VAH and/or VAIH. 4. Public benefit claims

The proposed conduct will be of benefit to the public because it will provide corporate customers with access to discounted airfares. It will promote competition by providing a more attractive alternative to existing corporate arrangements.

(b) Facts and evidence relied upon in support of these claims:

There are currently a large number of airlines servicing Australia including but not limited to Aerolineas Argentinas, Air Caledonie, Air Canada, Air China, Air India, Air Mauritius, Air New Zealand, Air Niugini, Air Vanuatu, AirAsia X, Asiana Airlines, British Airways, Cathay Pacific Airways, China Airlines, China Eastern Airlines, China Southern Airlines, Delta Air Lines, Emirates, Etihad Airways, Eva Air, Fiji Airways, Garuda Indonesia, Hawaiian Airlines, Indonesia AirAsia, Japan Airlines, Jetstar, Jetstar Asia, Korean Air, LAN Airlines, Malaysia Airlines, Our Airline, Philippine Airlines, Qantas Airways, Qatar Airways, Royal Brunei Airlines, Scoot, Sichuan Airlines, Silk Air, Singapore Airlines, Solomon Airlines, South African Airways, Thai Airways International, Tigerair, United Airlines, Vietnam Airlines and Virgin Atlantic Airways. In addition there are several airlines flying domestically in Australia including Qantas, Jetstar and regional airlines such as Airnorth, Skytrans Airlines, Sharp Airlines, Vincent Aviation, Airlines of Tasmania, Alliance Airlines and Regional Express all of whom offer or are able to offer corporate rates.

5. Market definition

Provide a description of the market(s) in which the goods or services described at 2 (a) are supplied or acquired and other affected markets including: significant suppliers and acquirers; substitutes available for the

The market for airline travel and associated services is highly competitive. Airline travel and associated services are offered by Qantas, Jetstar, VAH and VAIH, plus many other international and regional airlines as noted above in 4(b). There are a large number of competitive offers available to the public in respect of the provision of airline travel and associated services at any given time.

6. Public detriments

(a) Detriments to the public resulting or likely to result from the notification, in particular the likely effect of the notified conduct on the prices of the goods or services described at 2 (a) above and the prices of goods or services in other affected markets:

VAH and VAIH submit that there is no likely detriment to the public resulting from the proposed conduct, and that the proposed conduct would have a negligible effect on competition in the markets noted above in clause 2(a).

(b) Facts and evidence relevant to these detriments:

The proposed conduct:

- in no way limits the genuine choice of customers in choosing whether to sign up to a corporate sales agreement.
- will not lessen competition as customers will be under no obligation to purchase VAH and VAIH airfares simply because they are signed up to a corporate sales agreement with an Alliance partner of VAH and/or VAIH and will be free to purchase airfares and/or associated travel content from airlines other than VAH and VAIH at market rates.

Thank you for your call this morning.

To clarify, the Form G is in relation to conduct which involves a Company signing up to a corporate sales agreement with an Alliance Partner whereby that Company receives discounted flights for corporate travel with the Alliance Partner and if they sign such a corporate sales agreement, they will also be provided with a discount on Virgin Australia flights. Without signing up to the Alliance Partner corporate sales agreement, the Company would not be provided the Virgin Australia discounted flights. The same applies to a Company signing up to a corporate sales agreement with Virgin Australia whereby that Company receives discounted flights for corporate travel with Virgin Australia and if they sign such a corporate sales agreement, they will also be provided with a discount on Alliance Partner flights. Without signing up to the Virgin Australia corporate sales agreement, the Company would not be provided the Alliance Partner discounted flights.

I will forward you a further cheque in the mail as discussed.
