Supatreats Australia Pty Ltd Exclusive Dealing Notification - Supporting Submission

Introduction

1. We act for Supatreats Australia Pty Ltd (ACN 602 203 190) (**Supatreats**).
2. This submission is made in support of the enclosed "Form G - Exclusive Dealing Notification" pursuant to the enclosed "Consent to Lodgement of Notification" from Supatreats.

Background

3. It is proposed that Supatreats will enter into franchise agreements pursuant to which it will grant franchisees the right to utilise the Wendy's franchise system.
4. The Wendy's franchise system incorporates an image and technique for the marketing, preparation and sale of specialised food and beverage products through kiosks and stores operating under the name "Wendy's" (**Wendy's Store**).
5. The Wendy's franchise system has been developed with the goal of providing customers with the opportunity to enjoy high quality tasting products on each and every visit to any Wendy's Store. This level of consistency extends to areas such as the design and layout of the Wendy's Stores, the style of the interior, the equipment, the provision of training, and the implementation of sales and marketing initiatives. This desired level of consistency is facilitated through controlling the origin and range of approved products and approved suppliers.

Exclusive Dealing Notification

6. Supatreats proposes to engage in conduct which may contravene section 47(6) of the *Competition and Consumer Act 2010* (Cth) (**the Act**), which consists of Supatreats supplying services to franchisees (namely, the grant of the franchise) on condition that they acquire goods (namely, goods used from time to time in the operation of the franchised business) from suppliers approved by Supatreats.

7. In particular, franchisees are to purchase Ingredients, Products and or Services from:
 - 7.1 the Franchisor;
 - 7.2 any Related Body Corporate of the Franchisor; or
 - 7.3 from Approved Suppliers when the Ingredients, Products and/or Services are unavailable from the Franchisor or any Related Body Corporate of the Franchisor within a reasonable time of receiving the Franchisee's written order.
8. If the franchisee wishes to obtain an Ingredient, Product (other than a Core Product) or Service from another supplier, the franchisee must first obtain written approval to do so from Supatreats. This approval will not be unreasonably withheld if the franchisee:
 - 8.1 gives Supatreats details of the nature and quantity of the ingredient, product or service, the name and address of the supplier and the price per unit charged by that supplier, the period that the price will be fixed and the terms and conditions of supply;
 - 8.2 deliver to Supatreats a sample of the ingredient or product;
 - 8.3 satisfy Supatreats that the proposed alternative supplier is able to maintain a continuity of supply; and
 - 8.4 satisfy Supatreats that the ingredient, product or service is at least equal in quality to the ingredient, product or service that it substitutes, suitable for the purpose for which it is intended and consistent with and not prejudicial to the Image or Standards under the franchise agreement.
9. Core Products are defined in the franchise agreement to be scoop ice cream, powdered soft serve, Chocollo, yoghurt, sauce purees and bag in box mixes.
10. A related entity of Supatreats, Supatreats Global Supplies Pte Ltd (**SGS**) (a company registered in Singapore), will arrange the supply of Core Products to franchisees by Everest Colonial Pty Ltd ACN 006 583 740 (**Everest**) and Frosty Boy Australia (**Frosty**).
11. Supatreats Australia Supplies Pty Ltd (ACN 604 473 823), a related company of Supatreats, will manage in Australia the relationship of SGS with Everest and Frosty.
12. We attach an indicative list of products that Supatreats proposes to direct franchisees to acquire from suppliers identified by Supatreats.
13. Accordingly, Supatreats wishes to seek immunity from legal action under the Act in relation to the exclusive dealing as described above and, for this purpose, we enclose by way of lodgment on behalf of Supatreats a Form G - Notification of Exclusive Dealing.
14. We enclose a cheque in the amount of \$100.00 payable to the ACCC in payment of the lodgement fees in this matter.

Submission in support of notification

15. We have identified below the public benefits and the public detriment resulting from the exclusive dealing conduct by Supatreats. In support of the Exclusive Dealing Notification, we submit that such public benefits will outweigh any public detriment.

Public Benefits

16. The following are the public benefits which result from exclusive dealing by Supatreats:

16.1 *Unique Products*

The Wendy's franchise system allows Supatreats to provide franchisees with a unique range of products created according to unique recipes and methods and with unique ingredients. By ensuring that only approved products are included in the menu items sold to customers, Supatreats reinforces the uniqueness of the Wendy's range of products and thereby strengthens the Wendy's brand.

16.2 *Identification of Ingredients*

As franchisees sell food to the general public, it is important that Supatreats is aware of, and controls, the ingredients of that food. This is because:

16.2.1 if food labelling is required, then Supatreats can facilitate that on behalf of franchisees; and

16.2.2 if a manufacturer issues a product recall, then Supatreats can coordinate that recall (or identify that no recall is necessary) in relation to franchisees.

16.3 *Consistency of Product Range*

The range of products available for consumption is consistent throughout every Wendy's Store, thereby providing a number of benefits to the customer. The customers can expect the same high quality service and products regardless of which Wendy's Store they visit. In addition, the customer has the comfort of a familiar menu allowing them to not only make their choice easily but also providing them with reassurance based on past visits that they will receive high quality products and services.

16.4 *Familiar Environment*

Ensuring that the Wendy's Stores are all designed within the distinctive style of the Wendy's franchise system means that the appearance, layout, décor, branding and packaging are familiar to customers. This familiarity helps to ensure that the customer's experience at any given Wendy's Store is a positive one.

16.5 *Consistency in Price*

The exclusive use of approved products from approved suppliers will allow a consistent price structure to be established throughout the Wendy's franchise system. As each franchisee will expend an equivalent cost for goods used in the production of menu items, consistent prices can be set for those menu items at all Wendy's Stores. The customer has the benefit of assurance of a consistency of products available and also a consistency in the cost of those products.

16.6 *Lower Prices*

The proposed conduct will allow Supatreats to, in effect, negotiate for the acquisition of goods on behalf of all franchisees. This will likely allow

franchisees to enjoy volume-based discounts that they would have been unable to obtain had they individually negotiated with the suppliers. This is likely to translate to lower prices for the franchisees' customers.

16.7 Consistency of Value

The operation of a system that sees consistency in price married with consistency of product quality means that customers can be certain of a correlation between cost and quality. This allows customers to not only view their experience as a pleasant one but also to see it as one that is of value to them.

Public Detriment

17. The public detriment which may result from the exclusive dealing by Supatreats is as follows:

17.1 Decreased Competition

Any exclusive dealing conduct will result in a decrease in competition in some way, shape or form. In this given instance the exclusive use of approved suppliers will affect competition in the markets within which those approved suppliers trade. Supatreats contends that any decrease in competition within these markets will be minimal, because under the Franchise Agreement a franchisee may, with authorisation from Supatreats, purchase products (other than Core Products) from a supplier who is not an approved supplier.


17.2 Freedom of Choice

The operation of the Wendy's franchise system means that the freedom of choice of a given franchisee to choose which goods and services they purchase is decreased. Despite this, the consistency of product, services, environment, price and quality that this decrease of freedom of choice provides results in an overall benefit to the franchisee. Franchisees benefit from the commercial viability of purchasing their goods from approved suppliers and through participating in a consistent system which helps to develop and maintain a unique brand that aids the franchisees in their goals of operating successful businesses.
