2. Notified Arrangement

(a) Description of the goods or services in relation to the supply or acquisition of which this notice relates:

Cellarmaster Wines Pty Limited will offer a range of offers to +Rewards members which include wines at a special price, wines with a bonus gift or wine vouchers.

(b) Description of the conduct or proposed conduct:

News Corp Australia operates the +Rewards program which provides rewards and benefits to certain News Corp Australia digital news service subscribers.

Through the +Rewards program, Cellarmaster Wines Pty Limited will offer to supply discounted product to certain News Corp Australia digital news service subscribers.

Cellarmasters will be able to refuse to offer the bonus or discounted goods unless the offeree has acquired certain News Corp Australia digital news services.

4. Public benefit claims

There are a number of significant public benefits which result from the proposed conduct:

- (a) Certain News Corp Australia digital news service subscribers can obtain discounted goods;
- (b) The offer may encourage competitors of News Corp Australia, including other newspapers, magazines and online media, to offer their customers and subscribers similar promotions and loyalty programs; and
- (c) Other retail competitors of Cellarmaster Wines Pty Limited may be encouraged to offer customer discounts through various newspapers, magazines or in store.

5. Market definition

It is not necessary to precisely define the applicable relevant markets affected as even in the narrowest potential market the notified conduct will not result in any lessening of competition.

6. Public detriments

The notified conduct would not result in public detriment, anti-competitive or otherwise, for the following reasons.

- Many businesses promote their products through customer loyalty programmes to increase awareness of new products or encourage general brand awareness and loyalty.
- News Corp Australia subscribers would be under no obligation to accept the offers from Cellarmaster Wines Pty Limited;
- The general public would be free to acquire relevant goods or services from other providers without any obligation to acquire a News Corp Australia news service subscription.
- Similar products are offered in the market and are highly competitive.

- Rewards programs encourage loyalty by customers and increase competition.
- The proposed conduct:
 - o in no way limits the genuine choice of customers in choosing a provider of the products described in section 2a;
 - will not lessen competition as customers will be under no obligation to register and/or acquire goods from the +Rewards program as described in 2b simply because they are a News Corp Australia digital news service subscriber, and similarly, non-subscribers will be free to acquire goods from other liquor retailers.
