Notice is hereby given, in accordance with subsection 93 (1) of the *Competition and Consumer Act 2010*, of particulars of conduct or of proposed conduct of a kind referred to subsections 47 (2), (3), (4), (5), (6), (7), (8) or (9) of that Act in which the person giving notice engages or proposes to engage.

#### 1. Applicant

Wild operates a unique system for the retail sale of products typically found in a cards and gifts business under its trade marked brand Wild Cards & Gifts.

Wild enters into franchise agreements with independently owned businesses throughout Australia (*Wild Franchisees*). A Wild Franchisee conducts its business using Wild's franchise system and sells goods at a retail level in association with trade marks which are licensed by Wild.

## 2. Notified arrangement

- (a) Description of the goods or services in relation to the supply or acquisition of which this notice relates:
  - Wild uses third party IT software and hardware solutions including a point of sale computer system called Infinity Retail Management System (*Infinity*). Infinity is owned by, and licensed to Wild and Wild Franchisees, by Triquestra New Zealand Limited (*Triquestra*).
  - (2) Infinity is used in store by Wild Franchisees as a mechanism to record and process transactions and reports regarding and including purchases, refunds, inventory, stock movement, stock receipts, stock adjustments, purchase orders, supplier details, returns to suppliers, transaction histories, sales summaries, end of day reporting, till balancing, financial

reports, sales and stock reports, sales summary by supplier, stock on hand reports, sales by item, layby, and stock label printing.

- (3) Wild head office inputs details including product barcodes, descriptions and department, and Wild head office and Wild Franchisees can update details including SKU number, sell price, and supplier details for example.
- (b) Description of the conduct or proposed conduct:

- (1) Wild wishes to require Wild Franchisees to use Infinity. By having Wild Franchisees use Infinity, Wild seeks to maintain among other things, uniformity and consistency among the product range, store and stock display, pricing, purchasing experience, stock ordering and back office reporting.
- (2) Wild is a party to a licensing and servicing agreement with Triquestra. Wild Franchisees sign up to a credit account with Triquestra and are responsible for paying monthly fees to use Infinity.
- (3) Wild Franchisees agree under the Wild Franchise Agreement to adhere to the quality and control standards prescribed by Wild. Wild Franchisees are informed through the Wild Disclosure Document and Franchise Agreement that Wild Franchisees may be required to acquire and use Infinity.
- (4) Triquestra charges new Wild stores a one off licensing and installation fee of \$4,700, then a monthly support and maintenance fee of \$100.

# **3.** Persons, or classes of persons, affected or likely to be affected by the notified conduct

Persons who are or will be a Wild Franchisee. Wild Franchisees are independently owned and operated Wild stores in Australia which sell franchise system goods at retail level.

#### 4. Public benefit claims

(a) Arguments in support of notification: (*Refer to direction 7*)

Wild operates a national franchise system in relation to the supply of Franchise System Goods under trade marks which are used by all Wild Franchisees. As such, consistency of goods and customer experience across all franchised outlets is an important commercial consideration.

The notified conduct would result in a benefit to the public by increasing efficiency and reducing costs for Wild Franchisees and Wild as well as providing consistent delivery of services, sale of goods, and quality control, thereby allowing Wild to be an attractive and competitive participant in the cards and giftware industry.

Requiring each Wild Franchisee to utilise the same provider of IT Goods and Services and, therefore, acquire uniform technology solutions, including a uniform point of sale, inventory control, back office and financial reporting solution, would also reduce transaction costs given that Wild can conduct negotiations with a single technology vendor in respect of a single solution that can be used across all Wild Franchisee stores. For example:

- Outsourced hardware and/or software maintenance agreements can incorporate the same service levels to ensure Wild Franchisees receive the same defined service levels.
- New features can be added to point of sale and other software and be implemented across all Wild Franchisees.
- Wild can efficiently and effectively monitor in-store elements of each Wild Franchise.

Wild regularly reviews the services provided by Infinity to ensure the system is the most beneficial and cost effective system for use in the franchise network and that the fees payable by Wild Franchisees are fair and most competitive.

(b) Facts and evidence relied upon in support of these claims:

It is submitted that the claims and benefits set out in the Notice are supported by:

- (1) Basic business and marketing principles.
- (2) Basic principles underlying a franchise network, how it is operated and the benefits of being part of or having franchise systems.

#### 5. Market definition
