Telstra proposes to:

- (i) give, or offer to give, a discount, allowance, rebate or credit in relation
 to the supply or proposed supply of broadband products or services by
 Telstra on condition that the person will acquire services from Stayz
 Pty Ltd ('Stayz') as a 'Stayz property owner' (i.e. the person lists their
 property to be advertised on Stayz.com.au as available for holiday
 rentals); and
- (ii) refuse to give a discount, allowance, rebate or credit in relation to the supply of broadband products or services by Telstra for the reason that

the person has not acquired, or has not agreed to acquire services from Stayz as a 'Stayz property owner'.


