Cairns Regional Council application for authorisation A91544 — interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received an application for authorisation from Cairns Regional Council on behalf of itself, Douglas Shire Council and Mareeba Shire Council. The ACCC invites you to comment on the application.

Cairns Regional Council is seeking authorisation to jointly tender to acquire waste collection services for an initial term of nine years with options to extend the initial nine year term for two additional 12 month periods (ie up to 11 years). A full copy of the application for authorisation is available on the ACCC's website www.accc.gov.au/AuthorisationsRegister.

Interim authorisation

Cairns Regional Council has requested interim authorisation to prepare and issue a Request for Tender, evaluate tender responses and negotiate with waste collection contractors. No new waste collection contracts will become effective unless and until final authorisation is granted by the ACCC.

The ACCC endeavours to deal with requests for interim authorisation quickly. In making an assessment as to whether it is appropriate to grant interim authorisation, the ACCC is not required to undertake a full assessment of the benefit and detriment likely to arise as a result of the proposed conduct.

The ACCC decides whether to grant interim authorisation on a case by case basis. Should an applicant request interim authorisation, the ACCC will usually consider a range of factors, including harm to the applicant and other parties if interim is or is not granted, possible benefit and detriment to the public, the urgency of the matter and whether the market would be able to return to substantially its pre-interim state if the ACCC should later deny authorisation.

Request for submissions

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed arrangements.

Submissions in relation to interim authorisation should be provided by 13 July 2016.

If you intend to provide a submission in relation to the substantive application for authorisation, please do so by **22 July 2016**.

Submissions, including oral submissions, will be placed on the ACCC's public register subject to any request for exclusion. Please see the ACCC's <u>guidelines for excluding</u> information from the public register.

The ACCC will progress its assessment of the application in a timely manner. An indicative timetable is set out below for your information

22 July 2016	Closing date for submissions from interested parties on substantive application for authorisation.
August 2016	Applicant responds to issues raised in the public consultation process.
August/September 2016	Draft determination.
September/October 2016	Public consultation on draft determination including any conference if called.
October/November 2016	Final determination.
