Application is hereby made under subsection 91C (1) of the *Competition and Consumer Act* 2010 for the revocation of an authorisation and the substitution of a new authorisation for the one revoked.

#### 2. Revocation of authorisation

Authorisation no: A91284. Authorisation in respect of collective bargaining on behalf of furniture and bedding retail members

(b) Provide details of the basis upon which revocation is sought:

Revocation and re-authorisation is sought from May 2017 due to expiry of authorisation granted on 12 April, 2012.

#### 3. Substitution of authorisation

(a) Provide a description of the contract, arrangement, understanding or conduct whether proposed or actual, for which substitution of authorisation is sought:

As a result of the initial authorisation given for collective bargaining, the Applicant has in place contracts with suppliers in accordance with the previous authorisation no A91284 to supply to Members in relation to furniture, bedding and related stock.

Pro Forma Terms and Conditions – Bedding & Terms and Conditions – Furniture are attached.

The Applicant seeks authorisation to continue collective bargaining with suppliers on behalf of Members in relation to furniture, bedding and related stock.

(b) Description of the goods or services to which the contract, arrangement, understanding or conduct (whether proposed or actual) relate:

Such contracts relate to purchasing of furniture, bedding and related stock and marketing services including but not limited to provision of catalogues and advertising in the media.

(c) The term for which substitute authorisation of the contract, arrangement or understanding (whether proposed or actual), or conduct, is being sought and grounds supporting this period of authorisation:

The authorisation is sought for a minimum of ten (10) years. Any lesser period places a considerable financial strain on this small Member based organisation. Each time an application is required to be made to renew the Authorisation with the ACCC – application costs, legal costs & wages are incurred by Homemakers on behalf of its members in preparing the submission. We don't foresee any major changes to the structure of the Group that would warrant an Authorisation being required to be reviewed in 5 years as against our requested 10 years, the extra authorisation period would assist in keeping costs reduced for the Group.

This application is made on behalf of current and future, presently unknown, Members of the Homemakers group. The current Membership of Homemakers is 76 retailers. It is anticipated that this group will grow to 85 within the next five (5) years.

#### 5. Public benefit claims

(a) Arguments in support of application for substitution of authorisation:

During the term of Authorisation No A91284 Homemakers have been able to negotiate agreements with suppliers on behalf of Members which has:

- made them price competitive with larger retailers in the same market;
- enable Members to rely on the negotiation skills of Homemakers to improve their bargaining power with suppliers;
- reduced the costs and time of negotiating with suppliers e.g Members
  Meetings costs as noted in 5B below. Also staff from Homemakers go
  overseas to source stock for the Group, this can be done on behalf of
  all the stores at a reduced cost rather than each of the stores having to
  do this and incur the costs themselves:
- given access to products more particularly imported goods which individual retailers would have neither the knowledge nor skill to obtain, as noted below in 5B;
- reduced warehousing costs for Members. As noted in 5B, as
  Homemakers is holding more stock in its warehouses it means that
  stores don't have to hold as much stock in their warehouses and
  ultimately saving the store in warehousing costs; and
- made savings in transactional costs for both Members and suppliers, as noted below in 5B re Advertising Costs, Website Costs and Members Meetings Costs.

(b) Facts and evidence relied upon in support of these claims:

#### Warehousing:

The Applicant has arranged warehousing for goods for its Members to enable bulk purchasing and to reduce the costs to Members. During the period of the initial authorisation the costs incurred by the Applicant on behalf of Members for warehousing is as follows:

Stock levels held by the Applicant have increased during the 5 year authorisation period due to bulk purchasing by the Applicant which has enabled Members to reduce the stock they hold in their stores while being able to offer a

wider variety to customers. During the period of the initial authorisation the Applicant's stock levels have grown from \$1.6M in 2012 to \$2.5M in 2016.

When a stores joins the Homemakers Group, they don't need to have as much warehouse space themselves as what they would if they were not part of the Group. This is the case as the member store that is part of the Group has access to order products that are either warehoused by Homemakers or supplied by a Preferred Supplier, the member store can get access to these products on a timely basis.

## Advertising

Sharing of advertising costs, particularly television advertising and production of catalogues has resulted in substantial costs savings to Members and enable them to participate in forms of advertising that they could not do as separate enterprises.

Costs efficiencies through sharing of advertising costs, particularly in Regional areas where the Members can advertise together in the same television market whilst getting the benefit of splitting the advertising placement costs.

In 2015 the Applicant employed a full-time marketing manager to oversee all marketing operations in the Group, previously this position was part-time. The Group increase its advertising expenditure in the last 5 years as follows: —

Further, the Applicant has developed and maintained a website presence for the Members at a cost of approximately \$100,000. This site is continually developed and maintained by the Applicant ensuring that the individual Members do not need to incur this expense.

In 2016, the Applicant employed a full-time Business Development Manager whose focus is to assist stores with cost efficiencies, store development and to become more competitive with others in the industry. This Business Development Manager together with the General Manager, Sleepzone Manager & W.A. Operations Manager visit Member stores to assist with business generally and to ensure that the stores have the right amount and types of products and that they are price competitive with other retailers in their area.

#### Other services:

The Applicant provides four Member meetings per annum, three in Victoria and one in Western Australia. Attendance at these meetings is not compulsory however they give the Members the opportunity to speak with suppliers about products currently and what products will be available, to purchase products

directly from the suppliers, to provide training regarding products which they can pass on to their customers at point of purchase.

These meetings provide cost efficiencies for both Members and Suppliers being able to meet centrally rather than in the individual Members stores.

The Applicant now provides an online ordering system for Members. This enables Members to check immediate stock quantities and to place orders with suppliers or directly from the Applicants warehouse. In addition, the Applicant provides product information regularly to its members stores, electronically and via printed documentation.

#### 6. Market definition

The Applicant submits that the relevant markets are as follows: –

- Supply of furniture and bedding stock in Victoria, New South Wales, South Australia, Queensland, Tasmania, ACT and Western Australia; and
- supply of advertising and marketing services to furniture and bedding retailers in Victoria, New South Wales, South Australia, Queensland, Tasmania, ACT and Western Australia

#### 7. Public detriments

There have been no public detriments resulting from the collective bargaining agreement that the Applicant is aware of, during the period of the authorisation. The substitute Authorisation is unlikely to result in less competition between the Homemakers Members due to:

- Members are not generally in close geographical locations;
- participation in the collective bargaining agreements is voluntary between the Members;
- there is no obligation to participate if they believe that such an agreement will adversely impact on their respective business.
