a) Supply or offer to supply Dealer Product and/or Promotional Product to customers on the condition that the customer acquires or agrees to acquire telco services or or service plans from Telstra. b) Refuse to supply or refuse to offer to supply a Dealer Product and/or promotional Product to customers for the reason that the customer has not acquired or agreed to acquire telco services or products or service plans from Telstra.

Dealer Products include mobile phones, phone systems, other telecommunications equipment, software, tablets, hand held computers, data products and internet services. Promotional Products can include vouchers, cinema tickets, electrical good and accessories. These are valuable products to many customer and the ability to acquire them a discount or at a lower cost may be significant to the consumer.


