26 July 2017	Closing date for submissions on requests for interim authorisation.

Indicative date	Stage in assessment process
August 2017	ACCC decisions on interim authorisation for both matters.
9 August 2017	Closing date for submissions on substantive applications for authorisation.
September 2017	ACCC draft determination for both matters.
September/October 2017	Public consultation on draft determination including any conference if called.
October/November 2017	ACCC final determination for both matters.
