Authorisation for Steeline Members Pty Ltd AA1000520

1. We refer to the ACCC's final determination dated 2 December 2020 (**Determination**) regarding the application for authorisation lodged by Steeline Members Pty Ltd (**Steeline**).
2. Paragraph 5.11 of the Determination states:

"Steeline must, at least 14 days prior to any new member joining Steeline, provide the ACCC, in a form that can be placed on the public register, then business name of the member and the names and locations (street addresses) of any stores that the member operates or will operate which supply metal roofing and/or other building products and/or associated products or services" (the **Condition**)

3. In accordance with the Condition, Steeline encloses at Annexure 1 the requested details of a new member joining the group.
