# Request for submissions: Propel Funeral Partners Limited's proposed acquisition of Gregson & Weight Funeral Directors

The Australian Competition and Consumer Commission (**ACCC**) is seeking your views on the proposed acquisition of Codfern Pty Ltd, which trades as Gregson & Weight Funeral Directors (**G&W**), by a subsidiary of Propel Funeral Partners Limited (**Propel**) (**proposed acquisition**).

Propel and G&W both provide funeral services in the Sunshine Coast and surrounding areas in Queensland. Further details can be found at **Attachment A**.

The ACCC's investigation is focused on the impact on competition and in particular, we are seeking your views on:

- how closely Propel and G&W compete with each other in supply of funeral director services and cremation services in the Sunshine Coast region
- the impact of the proposed acquisition on prices and service levels for funeral directing and/or cremation services
- the extent to which Propel may have the ability and incentive to restrict access and/or increase prices at the Buderim Crematorium.

Further issues you may wish to address are set out in **Attachment B**.

This matter is public and you can forward this letter to anybody who may be interested.

The legal test which the ACCC applies in considering the proposed acquisition is in section 50 of the *Competition and Consumer Act 2010*. Section 50 prohibits acquisitions that are likely to have the effect of substantially lessening competition in a market.

#### Attachment A

#### **Propel**

Propel is a Sydney-based publicly listed company which operates in the death care industry in Australia and New Zealand. It owns funeral director companies, along with cemeteries, crematoria and related assets. Propel operates from 120 locations, including 28 cremation facilities and 9 cemeteries.

Propel supplies funeral directing services on the Sunshine Coast and surrounding areas under the 'Premier Funerals' brand. Propel has a site in Currimundi and owns and operates the Buderim Crematorium, which provides cremation services, chapel services and memorial sites.

Premier Funerals also supplies funeral director services from a site in Oxley, in the Brisbane region.

# G&W

G&W started operating in the 1970s and is the largest funeral services provider in the Sunshine Coast region. G&W provides funeral directing services from four locations: Caloundra, Buderim, Nambour and Noosaville. It operates crematoria at three of those sites: Caloundra, Nambour and Noosaville.

#### The proposed acquisition

Propel proposes to acquire 100% of the issued share capital in Codfern Pty Ltd (trading as Gregson & Weight Funerals), and certain freehold properties on the Sunshine Coast.

Propel proposes to acquire all assets and facilities associated with the operation of the G&W funeral business (as seen in Table 1) as well as the freehold properties from which the businesses operates in Caloundra, Buderim and Nambour. It will also lease the property situated in Noosaville.

- 8. The ACCC understands Propel's Buderim Crematorium is the only crematorium in the Sunshine Coast region which provides third party services to competing funeral directors. To what extent will Propel have the ability or incentive to restrict access and/or increase prices at the Buderim Crematorium if the proposed acquisition proceeds?
- In the instance that funeral directors in the Sunshine Coast region could no longer access the Buderim Crematorium, what facilities would they use for:
  - a) cremations
  - b) ceremonies
  - c) memorialisations.

# New crematoria in the Sunshine Coast region

- 10. Please identify potential new entrants to the supply of crematorium services (including cremations, chapel, memorial gardens etc.) in the Sunshine Coast region. In your response, please provide details regarding:
  - a) estimated time and cost of market entry, and the extent to which such costs would not be recoverable upon exiting the market
  - b) the minimum size of operations required for entering the market (e.g. number of cremations)
  - c) any regulatory barriers, such as environmental or planning regulations
  - d) the importance of reputation
  - e) long term trends for cremation services (including consumer demand and industrial cremation sites).
- 11. If Propel restricted access to and/or increased prices for cremation services for competing funeral home operators, how likely is it that those operators may open their own competing crematorium or sponsor a third party's entry (having regard to the factors listed in the question above)?
