As stated in our original submission to the ACCC, \$0.15 per litre probably does not sound like much to pay for the privilege of disposing of unwanted or unused paint in an environmentally responsible manner, **However reality is.....**

We have paid \$14,000.00 in Paintback levy, that equates to 408 litres per week. That is \$14,000.00 for a service we cannot use and have never used...........

One of the main reasons Nick Favot Painting cannot and has never used this service is because Paintback accepts a maximum of 100 litres in volume per visit. REGARDLESS IF THE PAINT BUCKETS ARE FULL OR EMPTY

Perhaps the ACCC needs to look at a <u>USER PAYS</u>, OR BENEFICIARY PAYS, A

PRICING APPROACH BASED ON THE IDEA THAT THE MOST EFFICIENT

ALLOCATION OF RESOURCES OCCURS WHEN CONSUMERS PAY THE FULL

COST OF THE GOODS THEY CONSUME.
