- all regulations and pricing determinations made under the IPART Act ${ }^{2}$
- all regulatory instruments applicable under the Licences ${ }^{2}$ : and
- Commercial Arbitration Act $1984{ }^{2}$.
(ii) good electricity industry practice and applicable Australian Standards.


## 6. Copies of amended documents

NorthPower undertakes to provide the $A C C C$ with an updated copy of an applicable regulatory instrument annexed to this undertaking whenever that instrument is amended.

## 7. Withdrawal or variation of undertaking

NorthPower may, with the consent of the Australian Competition and Consumer Commission, withdraw or vary this undertaking at any time.
