Statement of differences—Wholesale Broadband Agreement

As of 21 February 2012, 35 access seekers had entered into access agreements based on the Wholesale Broadband Agreement (**WBA**). At that time, the WBA was available on NBN Co's website as a standard form of access agreement (**SFAA**).

On 21 February 2012, NBN Co issued a notification to all 35 access seekers on access agreements based on the WBA that the terms of their access agreements would be changing via notice under the change management provisions set out in that agreement. The names of these access seekers are provided at **Attachment A** to this letter.

NBN Co is providing this statement of differences in the form specified in the *Part XIC non-discrimination guidelines* published by the ACCC in April 2012.

These access agreements are different from the SFAA in place on 21 February 2012 in the following respect:

1. The introduction of an updated WBA Operations Manual (effective 4 April 2012).

Enclosed is a marked-up copy of the WBA Operations Manual for the purpose of specifying how the access agreements entered into by the customers listed in Attachment A on 21 February 2012 differ from the relevant SFAA published as at that date.

Any terms not defined in this letter should be read as defined in copies of the relevant parts of these access agreements provided with this letter.

NBN Co provides this statement of differences having regard to section 152BEBA of the *Competition and Consumer Act 2010*. As of the effective date of these changes, the SFAA was updated to reflect the differences set out in the attached document. The difference in question arises solely due to the timing of when the SFAA was updated by NBN Co.
