## Statement of differences—Wholesale Broadband Agreement

As of 7 February 2012, 33 access seekers had entered into access agreements based on the Wholesale Broadband Agreement (**WBA**). At that time, the WBA was available on NBN Co's website as a standard form of access agreement (**SFAA**).

On 7 February 2012, NBN Co issued a notification to all 33 access seekers on access agreements based on the WBA that the terms of their access agreements would be changing via notice under the change management provisions set out in that agreement. The names of these access seekers are provided at **Attachment A** to this letter.

NBN Co is providing this statement of differences in the form specified in the *Part XIC non-discrimination guidelines* published by the ACCC in April 2012.

These access agreements are different from the SFAA in place on 7 February 2012 in the following respects:

- 1. The introduction of an updated WBA Product Catalogue (effective 4 April 2012);
- 2. The introduction of the first version of the Facilities Access Service Product Description (effective 4 April 2012):
- The introduction of the first version of the Facilities Access Service Product Technical Specification (effective 4 April 2012);

Please note that the Facilities Access Undertaking and other Facilities Access Service-related documents, not part of the WBA, were also provided as part of this notification, but have not been included in this statement of differences as they do not involve changes to the access agreements themselves.

Enclosed are marked-up copies of the WBA Product Catalogue and clean copies of the Facilities Access Service Product Description and Facilities Access Service Product Technical Specification, for the purpose of specifying how the access agreements entered into by the customers listed in Attachment A on 7 February 2012 differ from the SFAA published as at that date.

Any terms not defined in this letter should be read as defined in copies of the relevant parts of these access agreements provided with this letter.

NBN Co provides this statement of differences having regard to section 152BEBA of the *Competition and Consumer Act 2010*. As of the effective date of these changes, the SFAA was updated to reflect the differences set out in the attached documents. The differences in question arise solely due to the timing of when the SFAA was updated by NBN Co.
