MY REPORT

- 8. I, together with my colleague Daniel Enoch Price (co-owner and Managing Director of Frontier Economics), have been requested by Ashurst Australia, lawyers for AGL Energy Limited (AGL), to prepare a joint expert report in these proceedings which addresses matters relating to the impact of AGL's proposed acquisition of Macquarie Generation on competition in relevant markets.
- 9. Ashurst Australia requested that Daniel Price and I prepare a report which identifies, in relation to AGL's proposed acquisition of Macquarie Generation:
 - (a) probable counterfactual scenarios to the proposed acquisition;
 - (b) the economic principles relevant to market definition and the markets relevant to determining the effect or likely effect on competition of the proposed acquisition;
 - (c) the economic principles relevant to determining the effect or likely effect on competition of "horizontal" and "vertical" mergers or acquisitions;
 - (d) any "horizontal" or "vertical" effects on competition (or likely effects), or efficiencies (or likely efficiencies), arising from the proposed acquisition.
- 10. Specifically, I have prepared sections 2.2, 4.1, 5.2, 6.2 and 8.1 of that joint report; Daniel Price has prepared the other sections of that report.
- 11. Annexed to this report and marked "**PW-2**" is a copy of the joint report dated 26 March 2014.
- 12. On 14 March 2014, I was provided with a copy of Practice Note CM7, entitled "Guidelines for Expert Witnesses in Proceedings in the Federal Court of Australia", by AGL's solicitors Ashurst Australia. I confirm that I have read Practice Note CM7 and that I have complied with the terms of Practice Note CM7 in preparing the report.
