Persons giving this undertaking

- This Undertaking is given to the Australian Competition and Consumer Commission (ACCC) by Samsung Electronics Australia Pty Ltd ACN 002 915 648 (Samsung) of 8 Parkview Drive, Homebush Bay NSW 2127, for the purposes of section 87B of the Competition and Consumer Act 2010 (Act).
- Samsung is incorporated under the *Corporations Act 2001* (Cth) and registered in New South Wales. Samsung is the subsidiary of the Korean manufacturing company, Samsung Electronics Co., Ltd. and carries on business in Australia as an importer and wholesaler of household electrical appliances.

Background

- In October 2010, Samsung launched a new washing machine model in a 7.5kg and 8.5kg variant (model numbers WF0754W7V and WF0854W8E respectively branded as Bubble Wash washing machines) (Samsung Washing Machine).
- The advertising campaign in relation to the Samsung Washing Machine ran from October 2010 to October 2011 and was comprised of:
 - (a) point of sale material, including 10,000 A5 product brochures and a demonstration kit incorporating a promotional video which was present at approximately 90 stores and was displayed from about March 2011 to October 2011;
 - (b) brochures at the Better Homes & Gardens LIVE trade show on 15 October 2010 which were distributed to consumers during the event;
 - (c) two print advertisements in the Better Homes and Gardens magazine on 13 October 2010 and 10 November 2010;
 - (d) television commercials for national metro and regional circulation on Channel 7 and Channel 9 in the weeks commencing 3 October 2010, 17 October 2010 and 1 May 2011 and between 22 May 2011 and 12 June 2011; and

- (e) a website media release on 26 May 2010 with a subsequent release on 6 October 2011 which remained until the end of the campaign.
- 5 The advertising campaign as a whole conveyed the following linked representations:
 - (a) the Samsung Washing Machine allows users to achieve washing results in cold water that are equivalent to washing results achieved when using warm water; and
 - (b) users can therefore obtain energy savings of up to 60% by washing with cold water instead of warm water while achieving similar washing results.
- The ACCC has conducted an investigation into the representations made in the advertising campaign and whether aspects of that campaign, namely the in-store demonstration kit incorporating a promotional video, were potentially misleading to consumers pursuant to sections 18 and 29(1)(g) of the Australian Consumer Law.
- 7 The ACCC's concerns relate solely to the representations made by Samsung in the instore demonstration kit incorporating a promotional video.

The concerns

- 8 The ACCC considers that the in-store demonstration kit and incorporated promotional video:
 - (a) lacked the detail of the linked representations that were made throughout the rest of the advertising campaign; and
 - (b) made comparative energy savings representations between the Samsung Washing Machine and a "conventional" washing machine to the effect that the Samsung Washing Machine offers significant energy savings over a "conventional" washing machine, when that is not the case.
- Accordingly, the ACCC is concerned that the comparative energy savings representations made in the demonstration kit and incorporated promotional video were likely to mislead consumers.
- Samsung has cooperated with the ACCC's investigation and wishes to address the concerns outlined in paragraph 9 above by offering this Undertaking in accordance with section 87B of the Act.

Commencement of Undertaking

- 11 This Undertaking comes into effect when:
 - (a) the Undertaking is executed by Samsung; and
 - (b) the ACCC accepts the Undertaking so executed.
- 12 Upon the commencement of this Undertaking, Samsung undertakes to assume the obligations set out in paragraph 13 below.

- 13 Samsung undertakes for the purposes of section 87B of the Act that it will:
 - (a) offer an extension of the manufacturer's warranty from 2 years to 5 years for the customers of the Samsung Washing Machine who purchased the product from the stores that displayed the demonstration kit and promotional video during the period from 1 March 2011 to 31 October 2011;
 - (b) send a letter to each of the customers referred to at undertaking (a) above (where it is possible to identify them) in the terms of **Annexure A** by no later than 31 January 2013;
 - (c) place a notification on its website in the terms of **Annexure B** by no later than 31 January 2013 with the notification to remain on its website for a period of at least three months; and
 - (d) conduct and implement a review and enhancement of Samsung's trade practices compliance program with particular reference to the conduct outlined in paragraph 9 above.
