UNDERTAKINGS TO THE AUSTRALIAN COMPETITION & CONSUMER COMMISSION
GIVEN FOR THE PURPOSE OF SECTION 87B
BY
GATEWAY PTY LTD (ACN 070 538 751)

PERSON GIVING UNDERTAKING

1. This undertaking is given to the Australian Competition & Consumer Commission (the *Commission*) by Gateway Pty Ltd, ACN 070 538 751 (*Gateway*) of 6-10 Talavera Road, North Ryde in the State of New South Wales under Section 87B of the Trade Practices Act 1974 (the *Act*).

BACKGROUND

2. Gateway operates a unique, direct, build-to-order business model which is unlike most traditional computer manufacturers.
3. Gateway builds to order thousands of systems per day in Asia, Europe and the United States of America.
4. Each Gateway system is personalised to each customer's order and operates on a "just-in-time" delivery system.
5. Gateway computers are built overseas for its customers in Australia. The majority of Gateway computers that are sold in Australia are manufactured in Malaysia with components sourced from a number of countries.
6. On 13 May 2000, Gateway caused to be published an advertisement on page 16 of the Sydney Morning Herald in which it promoted various PC packages. The advertisement contained the following representation: "*Save up to \$699 before the GST*" (the *Representation*).
7. The Commission formed the view that the advertisement was misleading and deceptive. The Commission considered that the Representation was in breach of sections 52 and 53(e) of the Act. The Commission indicated that its concern stemmed from the possibility of consumers being misled into believing that purchasing a computer then at the "special pre-GST" price would result in greater savings rather than delaying purchase until after the imposition of the GST, on 1 July 2000. The Commission further considered that as computers were then currently subject to a wholesale sales tax rate of 22%, the price for computers would be expected to decrease from 1 July 2000.

8. The Commission indicated it was concerned that Gateway staff were also making certain representations regarding the effects of the New Tax System changes on the prices for Gateway computer systems which it alleged breached the Act.
9. Without any admission, Gateway co-operated with the Commission and offered to resolve these matters to meet the Commission's concerns. Gateway offered to refund the appropriate amount to any of its customers who placed an order for one of the relevant computer systems during the period from 4 to 14 May 2000 inclusive, and who received actual shipment of the relevant systems. This was the period during which the advertisement referred to in paragraph 6 above, applied. The refund will equal the difference between the price paid for the product under the special offer and the price of the product immediately following the introduction of the GST, that is, \$200 for an Essential 500SEC, \$100 for a Performance 700, and \$100 for a Solo 2150LS. Further, to ensure future compliance with the Act, Gateway will finish implementing its Trade Practices Compliance Program.

COMMENCEMENT OF UNDERTAKING

10. This undertaking comes into effect when:
 - (a) The undertaking is executed by Gateway; and
 - (b) The Commission accepts the undertaking so executed.

UNDERTAKINGS

11. Without admissions, Gateway gives the following undertakings to the Commission for the purposes of section 87B of the Act:-
 - (a) Gateway will not advertise its products in such a way that consumers may be misled or deceived regarding the application and/or effect of the New Tax System changes on the price of products supplied by Gateway.
 - (b) With respect to each person who placed an order for one of the relevant computer systems during the period from 4 May 2000 to 14 May 2000 inclusive, and who received actual shipment of the relevant systems, Gateway will:
 - (i) Within 2 weeks from the date of acceptance of the undertaking by the Commission, send a letter to each such person offering them a refund; and
 - (ii) Provide to each such person a refund cheque in the amount of \$100 or \$200, depending on which system was purchased.

Attached to this undertaking is a Schedule which lists the people who are entitled to receive a refund and the amount of each refund.


- (c) Within 3 months of the acceptance of the undertaking by the Commission, finish implementing its Trade Practices Compliance Program.
- 12. The undertakings referred to in paragraph 11 above will remain in force for a period of 5 years from the date of acceptance of the undertaking by the Commission.

- 13. Gateway acknowledges the Commission's right to make this undertaking available for public inspection and notes that the Commission will, at its discretion, from time to time, publish and publicly refer to this undertaking.
